1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$315,000 shall be made available to the Department of Housing and Community Development
3	Service 745 (Housing Code Enforcement) as a Supplementary General Fund Operating
4	Appropriation for Fiscal Year 2025, to provide funding for additional staffing costs. The source
5	of revenue for this appropriation is funds from the General Fund Assigned Fund Balance in
6	excess of the amount from this source that was relied on by the Board of Estimates in
7	determining the tax levy required to balance the budget for Fiscal Year 2025.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
