16 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That  
17 Sections I and II of the Parking Management Plan for Residential Permit Parking Area 26 -  
18 Campbell Lane read as follows:

19 **Residential Permit Parking Program**  
20 **Parking management Plan Restatement**  
21 **RPP Area 26-Campbell Lane**

22 **I. A Residential Permit Parking Program Area known as Area 26, governed by Article**  
23 **31, Subtitle 10, of the Baltimore City Code, exists for the block faces of the streets**  
24 **listed below:**

26 500 block of Campbell Lane, [odd side only,] BOTH SIDES, both sides posted

**[II. The parking restrictions that will be posted and enforced in Area 26 is:]**

[Two Hour Parking Limit / 7:00am – 7:00pm Monday through Friday / Except with Area #26 Permit]

**II. PARKING RESTRICTIONS:**

**A. IN GENERAL.**

EXCEPT AS PROVIDED IN ITEM B., THE PARKING RESTRICTIONS THAT WILL BE POSTED AND ENFORCED IN AREA 26 IS TWO HOUR PARKING LIMIT / 7:00AM - 12:00 AM MONDAY THROUGH FRIDAY / EXCEPT WITH AREA #26 PERMIT

**B. EXCEPTION.**

THE PARKING RESTRICTIONS THAT WILL BE POSTED AND ENFORCED IN AREA 26, 500 BLOCK OF CAMPBELL LANE, EVEN SIDE ONLY, IS THREE HOUR PARKING LIMIT / 7:00AM - 12:00AM MONDAY THROUGH FRIDAY / EXCEPT WITH AREA #26 PERMIT

**SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the 30<sup>th</sup> day after the date it is enacted.
