REQUEST: Historic Landmark Designation/Riverside Park-Randall and Johnson Streets

**RECOMMENDATION:** Approval

#### SITE/GENERAL AREA

<u>Site Conditions</u>: Approximately 17 acres, Riverside Park abuts railroad tracks and I-95 highway on the south and streets lined with late 19<sup>th</sup>-century rowhouses on the east, north and west. The park comprises an active recreation area and a passive area. The southern half of the park features baseball diamonds, basketballs courts, football and soccer fields, a play ground and a large swimming pool. The passive area still retains its historic entrance ways, an historic pavilion, and a cannon memorial. The park is tied together by a pathway system that resembles the original Victorian design.

General Area: Riverside Park is located in the Riverside neighborhood, a predominantly 19<sup>th</sup>-century, two-story rowhouse community. Interstate-95 and railroad tracks abut the south side of the park.

## CONFORMITY TO PLANS

The landmark designation reinforces the historic character of Riverside Park and highlights the park as a site in the Battle of Baltimore during the War of 1812. The park will be zoned for parks and open space. Landmark designation conforms to the CMP PLAY/Goal 1, Obj. 1/strategy 5 Prepare for the bicentennial anniversary of the War of 1812; and CMP PLAY/Goal 1, Obj. 4: Strengthen Stewardship of Historical and Cultural Resources. In addition, the landmark designation supports the Baltimore Heritage Area plan. In 2008, the Baltimore Heritage Area will hire a War of 1812 Bicentennial coordinator to oversee the celebration.

### ANALYSIS

Riverside Park is an important site of the Battle of Baltimore during the War of 1812, and an excellent example of Victorian park design.

Riverside Park meets CHAP's standards for landmark designation one, three, and five:

- Standard #1: Riverside Park area played an important role in the Battle of Baltimore during the War of 1812. To commemorate this area's role, the City purchased three acres in 1862 and named the area Battery Square. In 1873, the city added approximately 14 acres to Battery Square and renamed it Riverside Park. Since this time, the park has provided passive and recreational opportunities to South Baltimoreans;
- Standard #3: This site is associated with the Battle of Baltimore during the War of 1812, where Fort Lookout, now the site of Riverside Park, helped prevent the landing of the British on the south side of the peninsula, near today's Port Covington.
- Standard #5: Many of the park components such as the pavilion, cannon memorial, entrances from Randall Street, and path system illustrate many Victorian landscape design features.

This is the second step in a three-step designation process. First, the designation proposal was approved by CHAP on July 10, 2007. Second, the Planning Commission will review the designation, and third, upon approval of the Planning Commission, CHAP will forward the designation to City Council for approval through the City ordinance process.

The Department of Recreation and Parks, Friends of Riverside Park, Riverside Park Community Association; and Riverside Action Group were notified of this hearing.
