### Major Issues Discussed

- Chair Bullock opened the hearing and introduced the bill.

- Councilmember Blanchard delivered opening remarks, expressing his enthusiasm for the hearing and highlighting the importance of middle school sports.
- Noell West, Assistant Deputy Mayor for the Chief of Staff's Office, speaking on behalf of the Mayor.
  - Emphasized the importance of equitable access to sports opportunities.
  - Noted that Baltimore now has one of the most robust middle school sports offerings in the country.
- Baltimore City Public Schools Presentation by Tiffany Boyd, Director of Athletics.
  - Prior to COVID-19, middle school sports received limited funding.
  - Discussed the partnership with Under Armour to launch hybrid programs that expose students to less common sports.
  - Highlighted district-wide competitive opportunities and collaboration with 14 partner organizations, including Coppin State University, Little League, and the National Coalition of Women's Sports.
  - Announced a new partnership with the Baltimore Children and Youth Fund (BCYF), which includes a \$300,000 investment launching this spring.
- Vice President Middleton asked about the role of school police in ensuring student safety.
  - Response: The school system relies on the school community, with officers assigned to large events and exploration of alternative security measures.
- Public Testimony
  - A middle school student testified about the importance of sports in building school spirit, preparing for high school athletics, and making friends.
  - Another student shared how sports help form bonds among students regardless of skill level.
  - Thomas Johnson Middle School Vice Principal discussed expanding athletics and the arts, noting the school now offers seven sports teams.
    - Mentioned challenges with coaching, uniforms, and time commitments.
- Baltimore Children and Youth Fund (BCYF) presentation reported investing over \$40 million in youth-serving organizations.
- Set a goal of achieving 63% middle school student sports participation by 2030.
- Highlighted the Charm City Youth Athletic Council, a youth-led group advising BCYF, City Schools, and the Charm City Sports Cabinet to promote youth leadership.
- Department of Recreation and Parks Presentation outlined goals and projections for the next three years:
  - Strengthen consistency and quality of programming.
  - Expand the variety of sports offered.
  - Improve coordination with City Schools.
- Vice Chair Parker praised BCYF's collaboration on sports initiatives.
  - Asked for clarification on the 63% participation goal—whether it refers to individual students or total sports seats.

- Response: City Schools is working to expand school participation; BCYF noted that the goal represents an overall target for access and can be supported by other funders. The ultimate goal is 100% access to movement and play.
- Asked about inclusion for students with special needs.
  - Response: City Schools stated that all students should have access; inclusive options such as bocce are currently offered.
- Raised questions about safety, athletic trainers, and coaching quality.
  - Response: Schools rely on medics at the middle school level; additional coaching training is being considered.
- Councilmember Blanchard revisited the 63% goal, asking whether facilities can support expanded participation.
  - Response: City Schools noted additional funding may be needed.
  - Recreation and Parks shared that new facilities are being designed to accommodate spectators, gyms, and multipurpose spaces, but emphasized that adequate funding will be essential to meet participation goals.
- Councilman Jones asked Recreation & Parks if they could think about creating a noncompetitive league, so that it is more inclusive.
- Councilwoman Ramos asked the Deputy Mayor will be convening all agencies for a conversation because all the information right now seems to be preliminary.
