As proposed, City Council Bill 16-0642 would authorize the Mayor and City Council to create a debt not exceeding \$45,000,000, (“the Debt”) for the purpose of supporting expansion of existing businesses, the improvement of cultural life and promotion of tourism, and redevelopment and development of properties or land in Baltimore City.

The intent of this bill is to ensure that the Debt is crated as a general obligation of the City pursuant to Section 7 of Article XI of the Constitution of Maryland.

The Department of Finance recommends approval of City Council Bill #16-0642.
