14	The revenue appropriated by this Ordinance represents \$12,911,344 in excess of the revenue		
15	relied on by the Board of Estimates in determining the tax levy required to balance the budget for		
16	Fiscal Year 2025.		
17	This additional revenue could not have been reasonably anticipated when the Ordinance of		
18	Estimates for Fiscal Year 2025 was formulated.		
19	This appropriation is made necessary by a material change in circumstances since the		
20	Ordinance of Estimates for Fiscal Year 2025 was formulated or is for a new program that could		
21	not have been reasonably anticipated when that Ordinance of Estimates was formulated.		
22	On October 15, 2025, the Board of Estimates recommended this appropriation to the City		
23	Council.

development agreement for City Spring Elementary/Middle School. The sour	ce of revenue for
this appropriation is General Fund assigned Fund Balance in excess of the am	ount from this
source that was relied on by the Board of Estimates in determining the tax lev	y required to
balance the budget for Fiscal Year 2025.
