AN ORDINANCE CONCERNING

**Supplementary ~~Special Revenue~~ General Fund Operating Appropriation –
Board of Elections – \$1,417,451**

FOR the purpose of providing a Supplementary ~~Special Revenue~~ General Fund Operating Appropriation in the amount of \$1,417,451 to the Board of Elections – Service 899 (Fair Conduct of Elections), to provide funding for emergency security equipment and unbudgeted mailing costs from 2024 elections; and providing for a special effective date.

Recitals

The revenue appropriated by this Ordinance represents \$1,417,451 in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2024.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2024 was formulated.

~~The source of this additional revenue is Income Tax - State Collected.~~

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2024 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On February 5, 2025, the Board of Estimates recommended this appropriation to the City Council.

1 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
2 \$1,417,451 shall be made available to the Board of Elections – Service 899 (Fair Conduct of
3 Elections) as a Supplementary ~~Special Revenue~~ General Fund Operating Appropriation for Fiscal
4 Year 2024, to provide funding for emergency security equipment and unbudgeted mailing costs
5 from 2024 elections. The source of revenue for this appropriation is Income Tax - State
6 Collected in excess of the amount from this source that was relied on by the Board of Estimates
7 in determining the tax levy required to balance the budget for Fiscal Year 2024.

8 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is
9 enacted.


