5 6 7 8 9	IF A COMMAND STAFF MEMBER IS MARRIED TO AN INDIVIDUAL WHO IS EMPLOYED BY A GOVERNMENTAL ENTITY THAT HAS SIMILAR RESIDENCY REQUIREMENTS AS THOSE IN SUBSECTION (B) OF THIS SECTION, THE POLICE COMMISSIONER OR THE POLICE COMMISSIONER'S DESIGNEE MAY GRANT THAT COMMAND STAFF MEMBER A WAIVER FROM THE REQUIREMENTS IN SUBSECTION (B) OF THIS SECTION.
10	(D) TERMINATION FOR FAILURE TO COMPLY.
11 12	IF A COMMAND STAFF MEMBER FAILS TO COMPLY WITH THIS SECTION THE COMMAND STAFF MEMBER IS AUTOMATICALLY TERMINATED.
13	(E) ANNUAL REPORTING REQUIREMENT.
14 15 16 17	NO LATER THAN JUNE 30 OF EACH YEAR, THE POLICE COMMISSIONER OR THE POLICE COMMISSIONER'S DESIGNEE SHALL SUBMIT A REPORT TO THE MAYOR AND CITY COUNCIL DETAILING THE RESIDENCY AND VOTER REGISTRATION STATUS OF ALL COMMAND STAFF MEMBERS.

AND BE IT FURTHER ORDAINED</b> , That this Ordinance applies only prospectively and may not be applied or interpreted to have any effect or application to the continued employment at the same level of any individual who, before the effective date of this Ordinance, is employed by the Baltimore Police Department as a member of its "command staff" as that term is defined in this Ordinance.
23 24 25	<b>SECTION 3. AND BE IT FURTHER ORDAINED</b> , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as part of this or any prior Ordinance.
