	A RESOLUTION ENTITLED
1	A COUNCIL RESOLUTION concerning
2	Allowing Students To Use MTA Bus Tickets and Transfers Until 8:00 P.M.
3	For the purpose of urging the MTA to instruct all transit operators to accept Baltimore City
4	Schools bus tickets and student transfer tickets as valid until 8:00 p.m. on school days.
5	WHEREAS, After-school opportunities help public school students
6	(1) acquire academic, cultural, and athletic skills,
7	(2) participate in positive activities with adult and older peer role models, and
8	(3) engage in stimulating, positive, and exciting activities, as opposed to the many
9	opportunities for negative activities before parents have arrived home from work, and
10	WHEREAS, After-school services represent a substantial investment from both the Baltimore
11	City budget and the City Schools budget, and therefore the City has an interest in those services
12	being used by the largest number of students possible; and
13	WHEREAS, Funded after-school activities have greatly increased in number over the past ten
13	years because of increased attention to the importance of these services; and
15	WHEREAS, Subsidized bus transportation is a critical factor enabling low-income students to
16	participate in after-school activities; and
17	WHEREAS, The travel window for use of subsidized bus tickets is ordinarily until 6:30 p.m.
18	but can extend until 8:00 p.m., provided that students have their bus tickets stamped by an
19	authorized stamp at their school; and
20 21	WHEREAS, It is often extremely difficult or impossible for students to get their subsidized bus tickets stamped by an authorized stamp, because
22	(1) the stamp is often inaccessible when students try to find an administrator to stamp
23	their ticket, or
24	(2) the stamp has been lost or stolen from the school, or

1 2 3	(3) the after-school activity takes place at an off-campus location, or the student is inhibited by the potential obstacles in the process from even trying to find the authorized stamp; and
4 5	<b>WHEREAS</b> , Students who participate in after-school programs at off-campus locations must "use up" their bus ticket in traveling to the off-campus location; and
6	WHEREAS, Special student transfer tickets expire 90 minutes after they are issued, meaning
7	that students who "used up" their bus ticket getting to an off-campus program have less than 90
8	minutes to participate and travel home before the transfer ticket expires; and

9	WHEREAS, Many students are concerned that their bus tickets or transfers will have expired
10	before they have traveled home if they stay for an after-school activity or travel to an off-campus
11	location for an after-school activity; and
12	WHEREAS, Eliminating the need for having bus tickets stamped and the 90 minute
13	expiration on student transfers <i>does not alter the already established policy</i> that from the end of
14	school until 8:00 p.m. is a reasonable window for secondary school students to participate in
15	after school activities; and

16	WHEREAS, Eliminating the need for having bus tickets stamped and the 90 minute expiration
17	on student transfers would make it easier for students to participate in after school activities,
18	because they could be assured of getting home before the 8:00 expiration of their ticket; and
19	WHEREAS, A major cause of student disruptions on MTA buses after school is over-
20	crowding and student frustration from overcrowded buses; and
20	crowding and student musifation from overcrowded buses, and
21	WHEREAS, Additional students participating in after school activities would likely reduce
22	overcrowding on buses and also disruptive incidents by spreading out homeward travel over a
23	longer period; and
24	WHEREAS, It is inequitable and unacceptable that public school students who can afford bus
25	fare are able to participate in certain after school activities but students who cannot afford bus
26	fare are "timed out" of participation because of bus ticket expiration.
27	Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That this
28	Body urges the MTA to instruct all transit operators to accept Baltimore City Schools bus tickets
29	and student transfer tickets as valid until $8.00 \text{ nm}$ on school days

- and student transfer tickets as valid until 8:00 p.m. on school days.
