### AN ORDINANCE CONCERNING

#### Urban Renewal - Oldtown -1 2 **Amendment 10** FOR the purpose of amending the Urban Renewal Plan for Oldtown to allow a conditional use, 3 upon approval by separate ordinance, on the property known as 533/535 located in the 500 4 block of Oldtown Mall; waiving certain content and procedural requirements; making the 5 provisions of this Ordinance severable; providing for the application of this Ordinance in 6 7 conjunction with certain other ordinances; and providing for a special effective date. By authority of 8 Article 13 - Housing and Urban Renewal 9 Section 2-6 10 Baltimore City Code 11 (Edition 2000) 12 Recitals 13 The Urban Renewal Plan for Oldtown was originally approved by the Mayor and City 14 Council of Baltimore by Ordinance 70-760 and last amended by Ordinance 07-498. 15 An amendment to the Urban Renewal Plan for Oldtown is necessary to allow a conditional 16 use, upon approval by separate ordinance, on the property known as 533/535 located in the 500 17 block of Oldtown Mall. 18 Under Article 13, § 2-6 of the Baltimore City Code, no substantial change may be made in 19 any approved renewal plan unless the change is approved in the same manner as that required for 20 the approval of a renewal plan. 21 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the 22 following changes in the Urban Renewal Plan for Oldtown are approved: 23

AND BE IT FURTHER ORDAINED</b> , That if any provision of this Ordinance or the application of this Ordinance to any person or circumstance is held invalid for any reason, the invalidity does not affect any other provision or any other application of this Ordinance, and for this purpose the provisions of this Ordinance are declared severable.

However, if the provisions are found to be in irreconcilable conflict, the one that establishes the higher standard for the protection of the public health and safety prevails. If a provision of this Ordinance is found to be in conflict with an existing provision of any other law or regulation that establishes a lower standard for the protection of the public health and safety, the provision of this Ordinance prevails and the other conflicting provision is repealed to the extent of the conflict.
