## SITE/GENERAL AREA

<u>Site Conditions</u>: The City right-of-way affected by City Council Bill #08-0114 is located under and across the 4200 block of Boston Street.

General Area: The affected right-of-way lies within the Canton Industrial Area Urban Renewal Plan. The area is primarily industrial and warehouse uses. The area is zoned M-3.

## **HISTORY**

- Ordinance # 90-637, approved June 20, 1990, established the Canton Industrial Area Urban Renewal Plan
- Ordinance # 00-129, October 25, 2000, is amendment #1 to the Canton Industrial Area Urban Renewal Plan

# **CONFORMITY TO PLANS**

This project is in conformance with the Baltimore City Comprehensive Master Plan with respect to Play Goal #3, Objective 2: Protect and Enhance Baltimore's Natural Habitat and Environmental Resources.

### **ANALYSIS**


Within the 4200 Boston Street, ExxonMobil owns a former gasoline refinery and a bulk storage terminal that is currently inactive. The company plans on installing several recovery wells on their property to assist with the recovery of their gasoline product.

The purpose of this Bill is to grant a franchise to ExxonMobil to utilize a portion of subterranean area under Boston Street to connect from their recovery wells to a storage tank. At this time, there is a storage tank that is located across from the ExxonMobil site at 1610 South Newkirk Street. ExxonMobil has an access agreement to this site. The company plans to connect the recovery wells at their site (4200 Boston Street) to the storage tanks (1610 South Newkirk Street) via an underground pipeline. It is in ExxonMobil operation plans to periodically empty the storage tanks by tanker truck and the collected gasoline product will be recycled.

The proposed connection between these sites will require a portion of the product recovery pipeline to be located in and begin approximately 4 feet below the surface of Boston Street right-of-way. The pipeline will be installed by using horizontal directional drilling techniques under the right-of-way from entry and exit trenches located on the Boston and South Newkirk Street properties. It is staff findings that the underground connection will not adversely affect the Boston Street right-of-way and the use of the street by the public.
