24-0489 - Children Youth and Families - Youth Commission - Amendment

For the purpose of amending the composition of the Youth Commission; providing for the compensation of Commission members; providing for the selection of certain officers; establishing the Executive Committee; providing for the membership and duties of the Executive Committee; requiring the adoption of a constitution and bylaws; updating the powers and duties of the Commission; providing for staff to the Commission; requiring agency cooperation with the Commission; and generally related to amending certain provisions related to the Commission.

24-0521 - Ordinance of Estimates for the Fiscal Year Ending June 30, 2025

INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 24-0553 - By City Council President (Administration - Office of the Mayor)

An Ordinance amending the composition of the Mayor's Anti-Animal Abuse Advisory Commission; altering procedures for meetings of the Commission; providing for staff to the Commission; providing for a special effective date; and generally relating to the Mayor's Anti-Animal Abuse Advisory Commission.

The bill was read the first time and referred to the Health, Environment, and Technology Committee.

Bill No. 24-0554 - By City Council President (Administration - Department of Housing and Community Development)

An Ordinance correcting an amendment regarding permit extensions made during the course of adopting the 2021 Edition of the Building, Fire, and Related Codes; and providing for a special effective date.

The bill was read the first time and referred to the Rules and Legislative Oversight Committee.

Bill No. 24-0555 - By Councilmember Ramos

An Ordinance increasing the minimum yard requirements in the EC-2 District; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 24-0556 - By Councilmembers Bullock, Dorsey, Burnett, Ramos, and Porter

An Ordinance limiting and phasing out the amount of tip credit an employer may deduct from the hourly wage of a certain employee; requiring certain disclosures before an employer may charge a consumer a service fee; requiring an employer to submit a certain quarterly report to the Director of Finance; defining certain terms; and generally relating to fair wages for tipped employees.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 24-0557 - By Councilmember Stokes

An Ordinance permitting, subject to certain conditions, the establishment, maintenance, and operation of a principal use parking lot on the property known as 1200 Brentwood Avenue (Block 1152, Lot, 026), as outlined in red on the accompanying plat; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 24-0558 - By Councilmember Cohen

An Ordinance repealing Ordinance 95-572, as amended by Ordinance 96-096, which designated certain properties a Business Planned Unit Development known as Lighthouse Point; and providing for a special effective date.

The bill was read the first time and referred to the Ways and Means Committee.

Bill No. 24-0222R - By Councilmembers Burnett and Torrence

A Resolution requiring the Baltimore City Police Department, and inviting the Office of State's Attorney for Baltimore City, the Police Accountability Board, the Baltimore City Sheriff's Office, and relevant stakeholders, to appear before the City Council to discuss Baltimore City Law enforcement's polices and procedures for safeguarding, accounting for, and disposing of property it confiscates, including money, during the course of its work.

The bill was read the first time and referred to the Public Safety and Government Operations Committee.

The President laid before the City Council the following Council Resolutions for first reading:

Bill No. 24-0223R - By Councilmember Cohen

Introduced (Read and adopted)

Declaring Baltimore City a Sanctuary for Individuals Receiving Gender-Affirming Care, Their Families, and Providers of Gender-Affirming Care

FOR the purpose of declaring Baltimore City a sanctuary city for transgender and nonbinary individuals and calling on all units of City government receiving City funds to safeguard an individual's right to gender-affirming health care by refraining from using City funds or resources to impose criminal punishment, civil liability, administrative penalties, or professional sanctions on recipients, the families of recipients, or providers of gender-affirming health care.

Recitals

WHEREAS, the Baltimore City Council rejects discrimination in all forms, values our LGBTQIA+ neighbors, and will safeguard the rights of our transgender and nonbinary residents given our shared belief that all LGBTQIA+ individuals are entitled to respect, compassion, and the blessings of individual liberty that are our common heritage.

WHEREAS, other states may adopt or expand laws that impose criminal punishment, civil liability, administrative penalties, or professional sanctions on health care professionals who provide gender-affirming health care and on persons who seek, receive, or assist another in receiving gender-affirming health care in the City of Baltimore.

WHEREAS, the State of Maryland passed the Trans Health Equity Act in 2023, that expands coverage for gender-affirming treatments for transgender Marylanders.

WHEREAS, Governor Wes Moore signed an executive order Protecting the Right to Seek Gender-Affirming Treatment in Maryland proclaiming that no State agency shall comply with a subpoena issued by another state, knowing that the subpoena seeks information solely because an individual or entity provided, received, assisted in providing or receiving, sought, inquired or responded to an inquiry about, or traveled to Maryland to obtain gender-affirming treatment that is permitted under the laws of this State for themselves or a child for whom they are the parent or legal guardian. WHEREAS, 65 percent of LGBTQIA+ youth surveyed by the Trevor Project in 2023 who are receiving gender-affirming care are concerned about losing access to this care, 1 in 3 LGBTQIA+ young people said their mental health was poor most of the time or always due to anti-LGBTQIA+ policies and legislation, and 41 percent of LGBTQIA+ young people seriously considered attempting suicide in the past year.

WHEREAS, the 2022 United States Trans Survey (USTS) of 92,329 transgender and nonbinary adults found that 98 percent of adults who received gender-affirming care were more satisfied with their lives.

WHEREAS, according to Trans Maryland trans and nonbinary people in Maryland experience challenges accessing health care, and 20.1 percent have no place to receive health care advice.

WHEREAS, for the purpose of this resolution, gender-affirming health care means any medically necessary treatment consistent with current clinical standards of care prescribed by a licensed health care provider in collaboration with their patient for the treatment of a condition related to an individual's gender identity.

WHEREAS, gender-affirming health care is evidence-based, medically necessary, and lifesaving.

WHEREAS, studies have shown that gender transition, including access to gender-affirming health care, improves the overall well-being of transgender and nonbinary people, and that access to gender-affirming health care for youth is associated with better mental health outcomes and lower risks of suicide.

WHEREAS, multiple health care institutions across the country have scaled back or have considered scaling back gender-affirming health care services in response to legal challenges, perception of legal risk, harassment, or threats of violence.

WHEREAS, many institutions providing gender-affirming health care are located in Baltimore and local advocates already report longer wait times and difficulty accessing medically necessary gender-affirming health care.

WHEREAS, the City of Baltimore has consistently declared its commitment to furthering transgender equity and supporting its growing transgender community through City Ordinance 23-0378 that prohibits the willful use of the incorrect name or pronouns of an individual.

WHEREAS, health care professionals providing, and individuals seeking, receiving, or assisting another individual who is seeking or receiving gender-affirming health care in the City of Baltimore should be protected from attempts to impose criminal punishment, civil liability, administrative penalties, or professional sanctions based on the laws of other states when gender-affirming health care is lawful in the State of Maryland and meets standards for good professional practice.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the Baltimore City Council declares Baltimore City a sanctuary city for transgender and nonbinary individuals and calls on all units of City government receiving City funds to safeguard an individual's right to gender-affirming health care by refraining from using City funds or resources to impose criminal punishment, civil liability, administrative penalties, or professional sanctions on recipients, the families of recipients, or providers of gender-affirming health care.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to Governor Wes Moore, the Director of the Maryland Commission on LGBTQIA+ Affairs, the Baltimore City Delegation to the General Assembly, the LGBTQIA+ Caucus of the Maryland General Assembly, the Mayor, the Director of the Mayor's Office of LGBTQ Affairs, the Office of Equity and Civil Rights, and the Mayor's legislative liaison to the City Council.

Councilmember Cohen made a motion, which was duly seconded, that the Rules be suspended.

There being no objection, the President declared that the Rules were suspended.

Then Councilmember Cohen made a motion, which was duly seconded, that the Resolution be adopted.

The roll was called on the motion, resulting as follows:

Bill No. 24-0224R - By Councilmember Cohen

Introduced (Read and adopted)

Honoring Carlton Ray Smith and Residents Impacted by the HIV/AIDS Epidemic

FOR the purpose of honoring the advocacy of Carlton Ray Smith and affirming the City's commitment to relentlessly pursuing funding to provide HIV/AIDS treatment and services to those in financial need.

Recitals

WHEREAS, the City Council expresses its deepest condolences for the loss of Carlton Ray Smith, lovingly known as "The Duchess", who was a longtime advocate for Baltimore's LGBTQIA+ community and those living with HIV/AIDs in particular. Carlton Ray Smith passed away on May 29, 2024 at age 61.

WHEREAS, in 2023, the City extended protections against discrimination based on an individual's HIV or AIDS status in regards to employment, public accommodations, education, healthcare, public welfare, and housing.

WHEREAS, HIV and AIDS remain diseases that disproportionately impact the LGBTQIA+ community, and same-gender loving gay men and transgender women in particular, as well as other members of Baltimore's communities.

WHEREAS, federal funding from the United States Health Resources and Services Administration's Ryan White Part B Maryland State Special Services HIV/AIDS program of the State of Maryland is being cut from \$17.9 million in fiscal year 2024 to \$5.3 million in fiscal year 2025, a 76 percent decrease.

WHEREAS, the Ryan White Program funds serve those people living with HIV/AIDS with the greatest economic need.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, that the City Council honors the advocacy of Carlton Ray Smith and affirms the City's commitment to relentlessly pursuing funding to provide HIV/AIDS treatment and services to those in financial need.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to Governor Wes Moore, the Director of the Maryland Commission on LGBTQIA+ Affairs, the Baltimore City Delegation to the General Assembly, the LGBTQIA+ Caucus of the General Assembly, the Mayor, the Director of the Mayor's Office of LGBTQ Affairs, the Baltimore City LGBTQ+ Commission, the Office of Equity and Civil Rights, and the Mayor's legislative liaison to the City Council.
