Analysis

Background & Current Law

Council Bill 25-0016R seeks to address disparities in Black maternal health outcomes within Baltimore by conducting an informational hearing involving key city agencies and stakeholders. The resolution aims to gather insights and discuss strategic initiatives such as community-based birthing centers, culturally affirming maternal care, enhanced housing security, and bias training for healthcare providers. It recognizes the critical disparity evidenced by a significantly higher maternal mortality rate among Black parents compared to other racial groups, emphasizing the necessity for targeted intervention and systemic reforms.

Adopting this resolution would significantly benefit Baltimore by potentially lowering maternal mortality rates among Black communities through tailored healthcare reforms and enhanced social support structures. Improved access to culturally sensitive maternal care, combined with initiatives addressing housing instability and bias in healthcare, would lead to healthier families and stronger community resilience. This aligns with the broader objectives of social justice and public health equity, fostering a more supportive environment for Black parents and ultimately promoting the overall well-being of the city.

Informational Hearing - Black Maternal Health

FOR the purpose of inviting representatives from the Health Department, Office of Equity and Civil Rights, Mayor's Office of Children and Family Success, and other relevant parties to appear before the City Council to provide insight on the perinatal and reproductive healthcare needs of the Black community of Baltimore and to discuss strategies to support access to effective perinatal and reproductive healthcare for Black parents.

8 Recitals

Quality perinatal and reproductive healthcare are vital to start a child's life in good health and provide a safe recovery for the parent. However, Black parents do not always have access to the full range of supportive care that is necessary for good health before, during, and after birth. In a 2023 report based on data from the National Vital Statistics System, the National Center for Health Statistics found that the maternal mortality rate for Black parents was 50.3 per 100,000 live births, more than 3 times as high as the rate for any other surveyed racial group.

The Baltimore City Council seeks to promote public health and justice by improving Black maternal healthcare. Black maternal health organization The Bloom Collective highlights the effectiveness of certain priority focus areas to correct this major gulf in health outcomes.

Investment in community-based birthing centers and culturally-affirming maternal care can improve health outcomes for parent and child by increasing the availability of care that is comprehensive in scope and sympathetic to the needs and experiences of Black parents.

Black-led community healing spaces, including peer support groups and trauma-informed therapy from providers with shared experience, can promote collective healing and address stress, anxiety, and postpartum depression.

Increasing housing security by prioritizing pregnant and postpartum parents in housing assistance programs and improving eviction protections will remove a major risk factor in negative maternal and infant health outcomes, especially considering the housing vulnerabilities that many Black Baltimoreans face.

Council Bill 25-0016R

Providing youth-focused reproductive education that does not oppress or pathologize sex and pregnancy, as well as increasing availability of contraception and reproductive health services, can also improve maternal mortality rates among young parents.

The City Council wishes to understand how practices such as these can best be implemented to improve Black maternal health outcomes, and what actions City agencies can take to further the goals of equity and justice in reproductive care.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, That the City Council invites representatives from the Health Department, Office of Equity and Civil Rights, Mayor's Office of Children and Family Success, and other relevant parties to appear before the City Council to provide insight on the perinatal and reproductive healthcare needs of the Black community of Baltimore and to discuss strategies to support access to effective perinatal and reproductive healthcare for Black parents.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Health Commissioner, the Director of the Office of Equity and Civil Rights, the Executive Director of the Mayor's Office of Children and Family Success, and the Mayor's Legislative Liaison to the City Council.
