Dear Honorable President Mosby and Members of the City Council:

I am pleased to inform your Honorable Body that I have signed into law this day the following bills:

23-0393 – Street Encroachment - 3424 Toone Street

For the purpose of permitting, subject to certain conditions, the construction and maintenance of a portion of a building projecting into the public right-of-way on the west side of Baylis Street, on the property known as 3424 Toone Street; and providing for a special effective date.

23-0394 – Street Encroachment - 229 East Montgomery Street

For the purpose of permitting, subject to certain conditions, the construction and maintenance of a portion of a building, projecting into the public right-of-way on the east side of the property known as 229 East Montgomery Street; and providing for a special effective date.

23-0397 – Rezoning - Western Side North Lehigh Street South West Corner Eager Street and Western Side North Lehigh Street 52-7 Feet South of Eager Street

For the purpose of changing the zoning for the properties known as Western Side North Lehigh Street South West Corner Eager Street (Block 6182, Lot 007), and Western Side North Lehigh Street 52-7 Feet South of Eager Street (Block 6182, Lot 008), as outlined in red on the accompanying plat, from the R-4 Zoning District to the I-2 Zoning District; and providing for a special effective date.

23-0399 – Planned Unit Development - Amendment - Benhurst Park

For the purpose of repealing Ordinance 09-161; approving certain amendments to the Development Plan of the Benhurst Park Planned Unit Development; and providing for a special effective date.

23-0423 - City Property - Renaming Cottage Avenue Park to Candy Stripe Park

For the purpose of changing the name of Cottage Avenue Park, located at North East Side 30 Foot Alley 2nd South West of Cottage Avenue Rear 3700-36 Cottage Avenue (Block 3335, Lot 067), to Candy Stripe Park.

23-0436 – Urban Renewal - Brooklyn-Curtis Bay - Renewal Area Designation and Urban Renewal Plan

For the purpose of repealing the existing Brooklyn-Curtis Bay Urban Renewal Plan and replacing it by designating as a "Renewal Area" an area situated in Baltimore City, Maryland known as Brooklyn-Curtis Bay, generally including both sides of Patapsco Avenue between the Harbor Tunnel Throughway and Pennington Avenue, both sides of Pennington Avenue between Patapsco Avenue and Ceddox Street, the west side of Curtis Avenue between Ceddox Street and Patapsco Avenue, both sides South Hanover Street between Jack Street and Chesapeake Avenue, and the south side of Potee Street between Patapsco Avenue and Frankfurst Avenue; establishing the objectives of the Urban Renewal Plan; establishing permitted land uses in the Renewal Area; providing that where there might be conflict between the provisions of the Urban Renewal Plan and the provisions of any Planned Unit Development, the provisions of the Planned Unit Development control; providing review requirements and controls for all plans for new construction; providing that the provisions of the Baltimore City Zoning Code apply to the properties in the Urban Renewal Area; establishing controls for off-street parking facilities; authorizing the conditions for acquisition of properties in the Urban Renewal Area; providing for review by the Department of Housing and Community Development of development or rehabilitation plans in the Urban Renewal Area with respect to their conformance with the provisions of the Urban Renewal Plan; providing for community notification of any permit application for the development or redevelopment of any property within the boundaries of the Urban Renewal Area; creating disposition lots and providing for specific controls on specific lots; providing for the term of the Urban Renewal Plan; providing for community review of all proposed amendments to the Urban Renewal Plan; making provisions of this Ordinance severable; approving appendices and exhibits to the Urban Renewal Plan; waiving certain content and procedural requirements; providing for the application of the Ordinance in conjunction with certain other ordinances; and providing for a special effective date.

INTRODUCTION AND READ FIRST TIME

The President laid before the City Council the following bills and Resolutions of the Mayor and City Council for first reading:

Bill No. 24-0473 - By President Mosby

An Ordinance amending the process of redrawing City Council districts; and submitting this amendment to the qualified voters of the City for adoption or rejection.

The bill was read the first time and referred to the Rules and Legislative Oversight Committee.

Bill No. 24-0474 - By City Council President (Administration - Department of Real Estate)

An Ordinance authorizing the Mayor and City Council of Baltimore to acquire, by purchase or condemnation, the fee simple or other interests in certain property known as Block 6990, Lots 1 through 7, and Block 6991, Lots 1 through 26, and the bed of Woodhouse Avenue needed for the purpose of laying out or extending a public road and the widening of Ralls Avenue as shown on Plat 240-A-56-A in the Office of the Department of Transportation; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 24-0475 - By City Council President (Administration - Department of Transportation)

An Ordinance authorizing the release and surrender by the Mayor and City Council of Baltimore of all of its interests in and to a 20 foot wide right-of-way and a 10 foot wide right-of-way through the property of Weldon Heights Homes, Inc., as shown on plats RW20-34176 and RW20-34429 on file in the Office of the Department of Transportation; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 24-0476 - By City Council President (Administration - Department of Transporation)

An Ordinance authorizing the release and surrender by the Mayor and City Council of Baltimore of all of its interests in and to the variable width right of way heretofore granted the City of Baltimore; the location and course of the variable width right of way to be released being shown on a plat numbered RW 20-36464; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 24-0477 - By City Council President (Administration - Department of Finance)

An Ordinance providing a Supplementary General Fund Operating Appropriation in the amount of \$8,700,000 to the Department of General Services - Service 734 (Capital Projects Division - Design and Construction), to provide funding for emergency repairs to the Baltimore Police Department headquarters' parking garage; and providing for a special effective date.

The bill was read the first time and referred to the Finance and Performance Committee.

Bill No. 24-0478 - By Councilmember Bullock

An Ordinance changing the zoning for the properties known as 1214-1224 Hollins Street (Block 0216, Lots 053-058), 21-23 South Carey Street (Block 0216, Lots 047-048), and 14 South Stockton Street (Block 0216, Lot 074), as outlined in red on the accompanying plat, from the R-8 Zoning District to the C-1 Zoning District; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 24-0479 - By Councilmember Bullock

An Ordinance changing the zoning for the properties known as 901 West Mulberry Street (Block 0157, Lot 015), 317-329 North Schroeder Street (Block 0157, Lots 008-014), 222 North Fremont Street (Block 0173, Lot 003), 811 West Saratoga Street (Block 0173, Lot 001, and 203 North Amity Street (Block 0173, Lot 004), as outlined in red on the accompanying plat, from the R-8 Zoning District to the R-9 Zoning District; and providing for a special effective date.

The bill was read the first time and referred to the Economic and Community Development Committee.

Bill No. 24-0480 - By Councilmember Conway

An Ordinance requiring a certain retail dealer in motor fuel to display the credit price of motor fuel on a certain sign; defining certain terms; establishing certain penalties; and generally relating to a retail dealer in motor fuel's credit price for motor fuel.

Homeless Persons' Memorial Day

FOR the purpose of recognizing December 21, 2023 as "Homeless Persons' Memorial Day" in Baltimore City.

Recitals

WHEREAS, December 21 marks the first day of winter and the longest night of the year and communities across the country have chosen this day to remember men and women who have died without a place to call home.

WHEREAS, safe, decent, and affordable housing has become increasingly inaccessible due to rising costs, racial inequities such as housing segregation, inadequate incomes, the decline of affordable units, and structural inequities.

WHEREAS, people experiencing homelessness have higher rates of chronic disease, are more susceptible to illness and injury, and are significantly more likely to die prematurely than their housed counterparts.

WHEREAS, Baltimore City joins communities nationwide to remember those who have died without a secure place to live, and to recognize that every member of society should have the right to safe and affordable housing.

WHEREAS, Baltimore City has committed to making homelessness a rare and brief experience, we recommit our community to working for affordable housing, livable incomes, and accessible healthcare, which we recognize as fundamental to the goal of ending homelessness.

Now, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF BALTIMORE, that the Baltimore City Council recognizes December 21, 2023 as Homeless Persons' Memorial Day in Baltimore City.

AND BE IT FURTHER RESOLVED, That a copy of this Resolution be sent to the Mayor's Office of Homeless Services and the Mayor's Legislative Liaison to the City Council.

Councilmember Stokes made a motion, which was duly seconded, that the Rules be suspended.
