AN ORDINANCE CONCERNING

**Supplementary General Fund Operating Appropriation –
Fire Department – \$6,224,688**

FOR the purpose of providing a Supplementary General Fund Operating Appropriation in the amount of \$6,224,688 to the Fire Department – Program 212 (Fire Suppression), to provide funding to pay for additional operating expenses; and providing for a special effective date.

Recitals

The revenue appropriated by this Ordinance represents funds from the Fiscal 2008 Net Parking Taxes and Miscellaneous General Fund Revenue in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2008.

This additional revenue could not have been reasonably anticipated when the Ordinance of Estimates for Fiscal Year 2008 was formulated.

This appropriation is made necessary by a material change in circumstances since the Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could not have been reasonably anticipated when that Ordinance of Estimates was formulated.

On May 14, 2008, the Board of Estimates recommended this appropriation to the City Council.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That \$6,224,688 shall be made available to the Fire Department – Program 212 (Fire Suppression) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2008, to provide

1 funding to pay for additional operating expenses. The source of revenue for this appropriation is
2 funds from the Fiscal 2008 Net Parking Taxes and Miscellaneous General Fund Revenue in
3 excess of the amount from this source that was relied on by the Board of Estimates in
4 determining the tax levy required to balance the budget for Fiscal Year 2008.
