12	Dante Barksdale, a longtime anti-gun violence activist, was known as the "heart
13	and soul" of Safe Streets Baltimore, an evidence-based, public health campaign
14	that seeks to reduce gun violence and homicides in Baltimore City. Mr. Barksdale
15	spent countless hours as a Safe Street Outreach Coordinator serving members of
16	the community in close proximity to the City property specified in this Ordinance.
17	As such, this Ordinance is to rename this location in honor of Mr. Barksdale, who
18	tragically lost his life on January 17, 2021, to honor of his memory and dedication
19	to the community that he once served.
