1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$400,000 shall be made available to the M-R: Office of the Inspector General - Service 836
3	(Inspector General) as a Supplementary General Fund Operating Appropriation for Fiscal Year
4	2021, to provide funding for unbudgeted positions. The source of revenue for this appropriation
5	is funds from the Recordation Tax in excess of the amount from this source that was relied on by
6	the Board of Estimates in determining the tax levy required to balance the budget for Fiscal
7	Year 2021.

**SECTION 2. AND BE IT FURTHER ORDAINED**, That this Ordinance takes effect on the date it is enacted.
