Relief, and Economic Security Act ("CARES") in excess of the revenue relied on by the Board of

15 Estimates in determining the tax levy required to balance the budget for Fiscal Year 2021.

5 resulting from the COVID-19 pandemic. The source of revenue for this appropriation is funds

6 from CARES in excess of the amount from this source that was relied on by the Board of

7 Estimates in determining the tax levy required to balance the budget for Fiscal Year 2021.
