19	This appropriation is made necessary by a material change in circumstances since the

1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$12,684,471.33 shall be made available to the Fire Department – Service 609 (Emergency
3	Medical Services) as a Supplementary General Fund Operating Appropriation for Fiscal Year
4	2021, to provide funding for emergency medical services, personal protective equipment, and
5	building improvement expenses resulting from the COVID-19 pandemic. The source of revenue
6	for this appropriation is funds from CARES in excess of the amount from this source that was
7	relied on by the Board of Estimates in determining the tax levy required to balance the budget for
8	Fiscal Year 2021.

9 SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
