20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
21	On September 15, 2021, the Board of Estimates recommended this appropriation to the City
22	Council.

1	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
2	\$104,264.17 shall be made available to the Liquor License Board – Service 850 (Liquor
3	Licensing) as a Supplementary General Fund Operating Appropriation for Fiscal Year 2021, to
4	provide funding for telework technology expenses resulting from the COVID-19 pandemic. The
5	source of revenue for this appropriation is funds from CARES in excess of the amount from this
6	source that was relied on by the Board of Estimates in determining the tax levy required to
7	balance the budget for Fiscal Year 2021.

SECTION 2. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it is enacted.
