Major Issues Discussed

- 1. Councilmember Sharon Green Middleton opened the meeting, introduced committee members and City representatives and read the bill into the record.
- 2. Councilmember Dorsey explained the purpose of the bill. The intent of the bill is similar to State law which focuses on certain similar drivers that are defined as "chronic offenders." His intention is public safety. The City already immobilizes cars that have three tickets for certain violations. He would like to make sure that the State law which would require the City to notify MVA about certain types of chronic offenders is being implemented.
- 3. Agency representatives provided testimony.
- 4. Hilary Ruley provided the Law Department's report. She pointed out that the State of Maryland only grants authority to the City to regulate for parking violations, but not for speed camera violations. If the bill were amended, it could be approved, but would fail to address the sponsor's intention. Changes to State law can be sought via the Maryland General Assembly
- 5. Liam Davis representing the Department of Transportation testified that the merit of the bill is notable. He would like to have further conversations with the sponsor of the bill. He provided information about the automated traffic violation enforcement and unpaid citations.
- 6. Pedro Aponte testified that the Department of Finance supports the bill. The Department of Finance is working with the State Department of Motor Vehicles Administration to implement certain laws for chronic drivers.
- 7. Shanon Conway, representing the Police Department, presented the Police Department's position on the bill.
- 8. The hearing was opened for public testimony. No one testified.
- 9. The hearing was recessed.
