Re: City Council Bill 22-0204 – Vacant Structures – 3-1-1 Complaint Fines

Dear President and City Council Members:

The Law Department has reviewed City Council Bill 22-0204 for form and legal sufficiency. It would add Subtitle 4A to Article 13 of the City Code to create an escalating fee scales for repeat 3-1-1 service requests to vacant structures.

The bill must be amended to reduce the fine amount to under \$1,000 as that is the maximum that state law allows the City to impose. City Charter, Art. II, § (48).

The bill must also be amended to remove the Director of the Environmental Control Board's discretion to decide whether to impose a \$50 late charge and to decide whether to revoke a license for non-payment of the fine or, alternatively, to give that discretion some legislative guidance. See e.g., Andy's Ice Cream v. City of Salisbury, 125 Md. App. 125, 162 (1999) ("municipal delegation of ministerial authority must contain sufficient guidelines to ensure that the officers carrying out the delegations will act in accordance with the legislative will, and not employ their own unbounded discretion. "); accord Dyer v. Board of Education of Howard County, 216 Md. App. 530, 539-540 (2014). The Law Department recommends that the bill be amended to simply state that the late fee shall be imposed, and the license shall be revoked, instead of may be imposed or may be revoked, respectively. An amendment effectuating this change is attached to this bill report. Finally, the Law Department notes a typographical error in line 5 on page 2: the reference should be to AM 200-4 not AM 20-4.

Subject to the required amendments, the Law Department can approve the bill for form and legal sufficiency.
