  - Low wages and high workloads are major concerns
    - o Talked about ARPA funding requests and why the requests were made
    - o There are pro-founded mental health issues in city
    - Higher caseloads due to COVID
    - o Backlog is incredibly challenging
    - o Priority of office will always be violent crime
    - Vacant houses are mostly in neighborhoods of color!
    - o Comments regarding poverty level in city
    - Conviction rate is flat
    - The Human Resources Department recommended increased salaries for her staff
    - Abolished 5 positions to give recommended wage increases
  - (Per Finance Department 5 positions were frozen not abolished)
