15	Comptroller of Baltimore City is hereby authorized to grant a Perpetual Easement to the		
16	Maryland State Highway Administration for the installation and maintenance of a traffic control		
17	device, sidewalk, and median in the vicinity of the intersection of MD Route 150 (Eastern		
18	Avenue) and the entrance to East Point Mall, Baltimore County, Maryland, and described as		
19	follows:		
20	Beginning for the same at a point on the south side of the Right of Way Line of		
21	MD Route 150 (Eastern Avenue) varying in width, said point of beginning being		
22	distant 48.19 feet offset to the right of station 64+79.12 feet measured along Base		
23	Line of Right of Way as shown on Plat 59795 filed in the State Highway		
24	Administration State Roads Commission, running thence along the south side of		
25	the Right of Way Line of MD Route 150 (Eastern Avenue);
