#### **Major Issues Discussed**

June 7, 2022 – Day Six – Budget Hearings

- 1. Six (6) agency representatives came before the committee/councilmembers to talk about his/her fiscal year 2023 budget proposal. Copies of all PowerPoint Presentations are on file
- 2. After each agency head concluded his/her presentation, the committee/council members asked questions, stated concerns, asked for clarification, and etc. And, if applicable went over the responses to letters of information sent to them. Some highlights of same were:

#### I. Health Department

- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Comments
    - Chairman Costello and other council/committee members thanked Dr. Dzirasa and her team for the good work of the Department
    - Our Health Department serves as a national model!
  - Dead Animal Collection/Animal Control/Needle Collections
    - What is the law and/or process for picking up or removing dead animals/birds/etc.?

- Animal Control Do you have enough staff and resources for what you are required to do? What are the duties of the staff in Animal Control?
  - Concern: Unleashed dogs in parks; sometimes can be scary!
    - What are your plans to partner with the Park Rangers on this issue?
- BARSC is reaching its capacity! Do you have any partnerships to help with this issue?
  - Concern: Stray animals and not having the resources to house them!
- Per Chairman Costello, "Please research and provide feedback about:
  - What other major cities are doing to combat:
    - Dead Rat Collections, and
    - Needle Collections
- Animal Hearing Panel
  - Who is on the panel?
  - Are they paid? Answer: Yes
  - Who appoints them?
  - Is the Hearing Panel like an Appeals' Panel?
    - o What are their roles?
  - Do we know if any other panels/boards that are appointed by an agency instead of being appointed by the Mayor?
  - Have you made any appointments to the Panel since being in your position?
  - Requested by Chairman Costello: Provide a roster to include the names of the panelists and the date when they were appointed to the panel.
  - To Law Department: Do you see any reason why changing the appointments to the Mayor and City Council instead?
- Per Chairman Costello, "Provide a follow-up on your plan to procure a hazard waste contract."
- School Nurses/Health Aides Service 310
  - How do you plan to build the gap in these services for children who are at home? "A workforce pipe line?"
  - What are the qualifications for school nurses?
  - Have you applied for ARPA funding for school nurses?
  - How many nurses do you have? Answer: Approximately 50 nurses and 150 aides
  - Requested by Member Stokes: Provide a list of the schools that actually have nurses and aides
- Pandemic Next Phase
  - Is of concern
    - Mental health issues
    - Increased drug usage
    - Increased violence and etc.
    - This is an increased sense of urgency!
    - We are seeing "hurt people" all across our nation!
    - What do you plan to do to address the mental health crisis?

- We can't just call the police department when mental health problem arises in neighborhoods!
- Baltimore City has the potential to be a national model!
- How are we geared up for:
  - o Boosters, vaccinations, contact tracing and etc.?
  - o How will you pay for it?
- Kirwan
  - Is the funding from Kirwan coming out of your budget or from BCPS? Answer: BCPS, \$3 million
- Healthy Homes
  - Lead and mold do you relocate families when it is detected?
- Reproductive Health
  - Roe vs. Wade was reversed is of concern
    - Expect to see a large influx of women coming to the City for reproductive health due to same
    - How is your department preparing for this and who may be some of your partners?
    - Have you been thinking about this shift?
    - Will you have any role in training in this area of reproduction health?
- Seniors/Older Population
  - The low rate of wills and state planning is of concern
  - What type of legal advice is being provided?
  - Do you have any legal partnerships?
  - Comments regarding the importance of communicating with seniors!
- Recovery Houses, Recovery and Overdoses
  - Concern recovery houses that are selling drugs!
  - How do you address these complaints and/or issues?
  - Have heard both good and bad reports about recovery houses!
  - Are our housing inspectors engaged when issues come up in recovery houses?
  - Requested by Member Cohen: Provide, "what is the local law and what is the role of housing inspectors?"
  - Unfortunately, there are some bad operators of recovery houses out there!
    - Do we have the ability to revoke licenses? If not, are we able to make sure operators comply with laws?
- Treatment Centers
  - Baltimore City have a significant concentration of treatment centers; this can cause problems
    - Our city should not be the only place for these centers!
    - Have you begun to partner with state level folks?
    - Comment: We can not discriminate against treatment centers!

#### II. Planning Department and Commission on Historical and Architectural Preservation

- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Tax Credits
    - How much revenue received for Historic Tax Credits? Answer: \$1.2 billion in investments from credit projects
    - Have you thought about expanding coverage of tax credits?

- The application process is very involved and a person can be denied! Is there a way to streamline the process?
- Flooding at 35<sup>th</sup> and Hillen Road can you talk about this?
- Capital Projects
  - Requested by Member Ramos on behalf of Member Burnett: Provide the map and list for capital projects, by district.
  - What is the possibility of switching from a six (6) year capital budget to a three (3) year capital budget plan to help get projects completed faster?
  - Requested by Member Torrence: Would like a meeting to discuss changing the capital budget approach.
- What is the Sustainability Sub-cabinet?
- What is the status of greenway trails?
- What is the status of the Sustainability Plan?
- Where are we with zero waste?

#### III. Mayor's Office of Employment Development

- The representative from MOED gave opening remarks, some were:
  - COVID
    - COVID have impacted their Office and their partners as well
    - Talked about some virtual services that helped their Office during COVID
  - Youth Works Program
    - Starts on July 5, 2022 for a period of 4 to 5 weeks
- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Job Hub is excited to have on in the 14<sup>th</sup> district!
  - Spanish Speaking Language
    - How many partners do you have that speak Spanish?
    - How many staff members speak Spanish? Answer: Three (3) employees
  - Youth Works Program
    - Comment: Thank you for helping keep our youth busy!
    - Year-Round Youth Works Program
      - There has been some discussion regarding this; talk about this
      - Comments regarding Lyft rides available for youth workers
    - Requested by Member Middleton: Provide: An updated job list to include:
      - Names
      - Emails, and
      - Job titles
  - Ex-Offenders/Apprenticeship Program
    - Are you working with ex-offenders that are just from the city or from around the State of Maryland?
    - Returning citizens/Released inmates What is the process for helping them adjust?
    - It is my understanding that an apprenticeship program is at the City Jail!
  - Budget

There is a lot of grant funding in your budget! What percentage of your budget is grant funded? Answer: 2/3 of the budget

- African American Male Engagement Office
  - Do you partner with them? Servicing young men on the streets!

Do you provide any services to homeless youth?

#### IV. Department of General Services

- New Director for DGS Mr. Berke Attila
- Ms. Nguyen-Nash introduced the new Director for DGS, stating he was hired just five
   (5) days ago.
- She also stated, "The city has 14 surplused schools that are vacant and the utilities and water is still on in all buildings. It is an ongoing battle to stay on top of the maintenance of these buildings, she said."
- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Surplused School Buildings
    - These building becomes a quick burden and eyesore for the community and council members!
    - When BCPS hand over these buildings do they have any idea for uses?
    - Comments:
      - Suggest investing in steel doors and security cameras for these buildings
      - o It seems like there is an organized group that goes into the buildings to vandalize and steal!
      - o Can you invest in security cameras? Answer: Security guards are on sites
      - o Does DGS have a long-term plan for maintaining city owned non-vacant buildings? And, what are the processes for same?
  - Fleet/Gas Prices
    - Are you investing in electric vehicles?
    - Request for Services do you track them?
    - Can you walk us through what is needed once the city takes ownership of a vehicle(s)?
    - How many in total (number of vehicles) you have in your fleet/inventory?
    - How many are actually needed?
    - What is the bare minimum of vehicles needed at a given time? Answer: 309
      - o Baltimore Police Department Fleet
        - > What is the status of their vehicles?
        - ➤ What does their fleet look like?
    - Requested by Chairman Costello: Provide the number of vehicles planned to be purchased in fiscal year 2023

  - Requested by Member Ramos: Provide a list of all DGS Properties; vacant and occupied

#### V. Police Department

• Commissioner Harrison introduced his staff and talked about the letter sent to him by the council/committee members. He briefly talked about his "dedication," to the job. Also stating the crossing guard positions have move to the Department of Transportation's budget.

- The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Chairman Costello gave opening remarks stating, "The condition of our Police Department is broken; there have to be:
    - A short-term approach
    - A long-term approach, and
    - A middle approach
    - He talked about violent crime in the city stating, 'It has gotten to be a new norm?'
    - The 11th district is very diverse and we hope to get answers tonight, he said."
  - Deployment of Officers
    - What plans can you offer to meet the request of the Council?
    - What is the role of the District Action Teams?
      - Do their schedules change? Answer: Yes
  - Requested by Member Middleton: Provide the following information for past two (2) years for each month by category for each district:
    - Number of drug arrests
    - Number of firearm arrests
    - Number of the search and seizure warrants
  - Questions
    - Of the 134 officers who are on medical leave, how many are eligible for retirement?
    - How many hours per day and per shift do detectives spend on the streets?
    - How many hours do they spend on the streets to investigate sex crimes?
    - Is there a summer plan for the Eastern district?
    - Are you zooming in on the 3 to 5 nuisance areas?
      - What accountability measures are you using for these areas?
    - Police Stat are you holding weekly meetings with officers?
    - Does each district have a Crime Analysis Unit? Answer: Yes
    - Do you research details of cross jurisdictional strategies from other counties and/or entities?
      - Is there anything in writing to verify your verbal meetings with other counties?
    - Have you requested additional sworn officers from surrounding counties? Answer: Yes
      - I am asking you to ask for more!
        - o I don't believe we have enough officers or resources! It is up to you to ask for assistance! You are responsible for execution!
    - To boost your clearance rate, have you received help from the federal and state levels?
      - What work has been done on these levels?
      - Is there anything the Council can do the help and/or assist?
      - Requested by President Mosby: Provide the federal and state level support you have received, (i.e. DEA, FBI, State Police, and etc.) to include:
        - Who you spoke with, and
        - o Details of what you asked for
    - Is there a plan for the "clutter of violence" that happens around the same time?

- Do you have a plan to address the open-air drug market?
- Do officers get disciplined when they say they can't do his/her job because of the Consent Decree? Answer: No, but training is provided to them
- Micro Zone Strategies Was this used in previous years? What is being done differently? What measures of success are you using?
- What are the most pressing issues in your office today?
- How many people work in communications?
  - How many techs do you sent out a day on average?
- How are the youth getting guns?
- Does the department have a re-entry program? Answer: No but partners with MONSE.
- Warrant Services
  - How many unserved warrants are on file?
  - How will you clear your backlog?
  - How do you audit the warrant services?
  - What is the strategy for closing warrants?
- What does accountability for failure look like?
  - Demotions, or etc.
  - When do we get to the point when crime within a district becomes unbearable?
  - Can a Commander thrive in the areas of mentoring and training but fail when it (in the area of) comes to violent crime?
  - When the number of patrol officers decreased what affect did this have on the department?
- Where are we with "Civilization?" Answer: At 18%
  - Would like the number of districts reduced
- How do you account for density?
- How do you detect abuse of overtime?
- Where are we with rape kits and how can we move forward with cases?
- What percentage of calls are for violent crimes?
- What percentage of the daily calls relate to 911 calls?
- Are internal complaints increasing or decreasing?

#### Comments

- Per Chairman Costello, "Plan to meet with you on a daily basis until all issues pertaining to false alarm reduction have been resolved."
- Changing culture in terms of trust; need to think strategically about the situation(s) at hand!
- Some residents don't even know which district he/she lives in nor know who the District Commanders are!
- Want to simply the way residents interact with each other
- Concern: Having four (4) different districts within a 2 to 4 block radius
- Want to know what your available strength(s) is!
- Being grossly understaffed every time I heard from your department; the more I believe we are living in a fiction!
- Attrition outpaces hiring; trend will not reverse!

- Requested by Member Dorsey: Provide staffing plan based only on current staff; want a staffing plan that does not include staffing shortages at all.
- More policing does not necessarily mean better services!
- When spikes in crime within a district is posted, how long does the data stay posted?
- Believes if vacant properties were cleared up it would help fight crime!
- Need to rethink how we are doing things!
- Topics of Concern:
  - Your strategies
  - Partnership on federal and state levels
  - Clutters of violence occurring around the same time
  - Follow-up
  - Asking for help from federal and state partners
  - Amounts of crime and death is frustrated; want results
  - Adequate documentation
  - Only 10 officers in the Eastern district
  - Open Air Drug Market
  - Police Engagement
  - Need plans and results
  - Not being notified by Department in a timely manner when crimes happen in his/her district
  - Gang violence
  - Getting officers out of the cars
    - Concern: Officers sitting in vehicle watching TV!
  - Parking enforcement problems/concern want overnight parking enforcement is this doable?
    - Parking trailers on city streets is illegal is concerned about officers' response to same
  - Community engagement a sense of urgency!
  - Immediate results
  - Need real outcome-based measures
  - Drug trade
  - Constituent frustration(s)
  - Mental Health Crisis
    - Need to get other professionals to do the work associated with mental health; should not be the officers' responsibility.
