Major Issues Discussed

- 1. Chairwoman Middleton opened the meeting, introduced committee members and City representatives and read the resolution into the record.
- 2. Councilmember Ramos provided written and oral testimony about the purpose of the resolution. She spoke about the need for strategies and resources to eradicate vacant housing.
- 3. Christopher Shorter provided information about the process used to gather recommendations to eradicate vacant housing. He emphasized that the administration is committed to eradicating vacant housing. A March 1, 2022 memorandum outlining suggested recommendation was prepared and a work group is in the process of implementing the recommendations. Each recommendation has been changed into a virtual task card with an assigned owner. All recommendations have been categorized into actions which can be accomplished in 3, 6, 9 months as well as 1 -2 years' timeframes. Some actions require separate financial allocations and will be prioritized. Various strategies are being implemented.
- 4. Alice Kennedy provided a progress report (see handout) of initiatives implemented to address vacant housing.
- 5. Henry Raymond provided information about recent expenditures for vacant housing. Recommendations outlined in the work group report will require more funding. The City's Annual Financial Plan will be reviewed to consider the impact of funding for vacant housing initiatives. He explained the City's bond rating, which is currently AA.
- 6. The committee discussed:
 - the need to have future reports summarizing implementation of the recommendations;
 - o planned and emergency demolitions;
 - demolition funding;
 - leveraging of funds for the various strategies,
 - o the City's bonding capacity in order to fund recommendations;
 - o a process for understanding prevention of vacancies;
 - o helping owner's with homeowners' insurance issues;
 - o owner's understanding property valuation;
 - o owners' access to housing information and resources;

- o creation of a blight elimination task force;
- o the need for community and stakeholder input;
- Impact Investment Areas;
- In Rem process for buildings and lots;
- o transitioning to implementation of the In-Rem process
- the connection between fire and vacancies;
- o financing for redevelopment/rehabilitation;
- o a national report on the creation of vacancy problems due to exclusionary zoning
- o updating the City's deed and title research process
- o reduction of blight near vacancies;
