Current Law

Baltimore City Code – Article 1, Subtitle 1-City Council, Section 1-6

§ 1-6. Agencies to provide legislative information.

It shall be the duty of the head of every City department or bureau established by the Baltimore City Charter or by ordinance to provide all technical materials, plats, drawings, and information that are requested by any member or the President of the City Council for the purpose of introducing legislation into the Council. (City Code, 1976/83, art. 1, §6.) (Ord. 76-080.)

Absent a learning, teaching, and working environment that is safe, students cannot achieve academically and will experience physical, social, and emotional consequences.

The responsibility of student safety cannot be isolated to the Baltimore City Public School System. Life does not stop at the schoolhouse doors. Improving the overall public health of youth must be addressed collectively by all individuals and institutions that impact the lives of youth in our City.
