# **Analysis**

### **Current Law**

Baltimore City Code; Article 6 – Historical and Architectural Preservation; Subtitle 3; Section 3-1; Ordinance and Finding Requirements.

In general, an ordinance of the Mayor and City Council is required to designate any area as an Historical and Architectural Preservation District. The ordinance must be supported by written findings of fact that the proposed District and its boundaries will comply with:

- (1) the requirements for Local Government Certification under the National Historic Preservation Act (16 U.S.C., Chapter 1A, Subchapter II);
- (2) the Secretary of the Interior's Standards for Identification and Registration; and
- (3) the Commission's own Historic Preservation Procedures and Guidelines.

## **Background**

Bill 22-0284 proposes to designate properties located within certain boundaries as the Sarah Ann Street Historic District. The 1100 block of Sarah Ann Street lies between West Mulberry Street on the north, West Saratoga Street on the south, North Arlington Avenue on the East; and Carrollton Avenue on the West. Sarah Ann Street is a historic alley street. The rowhouse properties are located in West Baltimore in the Poppleton neighborhood.

The historic designation proposal consists of a total of 13 properties (1102 -1124 Sarah Ann Street and 321 and 323 Carrollton Avenue). The properties, built in 1870, represent historical housing and home ownership of African Americans over a period from 1870 to 1970. The properties also represent a unique and intact building type known as alley houses, a rare survivor of Baltimore's 19<sup>th</sup> Century working-class houses. There are eleven (11) two-story and one (1) three-story rowhouse structures on Sarah Ann Street. Two (2) three-story properties located on the 300 block of North Carrolton Avenue are also proposed for inclusion in the historic district designation.
