### AN ORDINANCE CONCERNING

#### Zoning – Conditional Use Conversion of a Single-Family Dwelling Unit to 2 Dwelling Units in the R-8 Zoning District – Variances – 2722 Auchentoroly Terrace

FOR the purpose of permitting, subject to certain conditions, the conversion of a single-family
dwelling unit to 2 dwelling units in the R-8 Zoning District on the property known as 2722
Auchentoroly Terrace (Block 3229, Lot 30), as outlined in red on the accompanying plat; and
granting variances from certain bulk regulations (lot area size) and required off-street parking
requirements..

15 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That

16 permission is granted for the conversion of a single-family dwelling unit to 2 dwelling units in

- 17 the R-8 Zoning District on the property known as 2722 Auchentoroly Terrace (Block 3229,
- 18 Lot 30), as outlined in red on the plat accompanying this Ordinance, in accordance with
- 19 Baltimore City Zoning Code §§ 5-201(a) and 9-701(2), subject to the condition that the building
- 20 complies with all applicable federal, state, and local licensing and certification requirements.

EXPLANATION: CAPITALS indicate matter added to existing law. [Brackets] indicate matter deleted from existing law. <u>Underlining</u> indicates matter added to the bill by amendment. Strike out indicates matter stricken from the bill by amendment or deleted from existing law by amendment.

**SECTION 2. AND BE IT FURTHER ORDAINED,** That pursuant to the authority granted by \$§ 5-305(a) and 5-308 of the Zoning Code, permission is granted from the requirements of \$9-401 (Table 9-401: Rowhouse and Multi-Family Residential Districts - Bulk and Yard Regulations), as the minimum lot size requirement for 2 dwelling units, in the R-8 Zoning District, is 1,500 square feet, and the lot area size is 1,200 square feet, more or less, thus requiring a variance of 20%.

SECTION 3. AND BE IT FURTHER ORDAINED, That pursuant to the authority granted by
 §§ 5-305(a) and 5-308 of the Zoning Code, permission is granted for a variance from the
 requirements of §§ 9-703(f), 16-203, and 16-602 (Table 16-406: Required Off-Street Parking) for
 off-street parking.

SECTION 4. AND BE IT FURTHER ORDAINED, That as evidence of the authenticity of the 11 accompanying plat and in order to give notice to the agencies that administer the City Zoning 12 Ordinance: (i) when the City Council passes this Ordinance, the President of the City Council 13 shall sign the plat; (ii) when the Mayor approves this Ordinance, the Mayor shall sign the plat; 14 15 and (iii) the Director of Finance then shall transmit a copy of this Ordinance and the plat to the Board of Municipal and Zoning Appeals, the Planning Commission, the Commissioner of 16 17 Housing and Community Development, the Supervisor of Assessments for Baltimore City, and the Zoning Administrator. 18

19 **SECTION 5.** AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the 30<sup>th</sup> day 20 after the date it is enacted.
