Estimates for Fiscal Year 2023 was formulated.		
This appropriation is made necessary by a material change in circumstances since the		
Ordinance of Estimates for Fiscal Year 2023 was formulated or is for a new program that could		
not have been reasonably anticipated when that Ordinance of Estimates was formulated.		
On December 21, 2022, the Board of Estimates recommended this appropriation to the City

3	(East Building Elevator Replacement) as a Supplementary General Fund Capital Appropriation
4	for Fiscal Year 2023, to provide funding to maintain the Baltimore City Convention Center in
5	good working order. The source of revenue for this appropriation are income tax funds in excess
6	of the amount from this source that was relied on by the Board of Estimates in determining the
7	tax levy required to balance the budget for Fiscal Year 2023.
