Recitals

14 The revenue appropriated by this Ordinance represents income tax funds in excess of the

15 revenue relied on by the Board of Estimates in determining the tax levy required to balance the 16 budget for Fiscal Year 2023.

This additional revenue could not have been reasonably anticipated when the Ordinance of
 Estimates for Fiscal Year 2023 was formulated.

- 19 This appropriation is made necessary by a material change in circumstances since the 20 Ordinance of Estimates for Fiscal Year 2023 was formulated or is for a new program that could 21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.
- On December 21, 2022, the Board of Estimates recommended this appropriation to the CityCouncil.

 PRJ002410 (915079 117-079 Infrastructure Platforms End of Life Refresh/Upgrades) as a

Supplementary General Fund Capital Appropriation for Fiscal Year 2023, to provide funding for

5 refreshing and upgrading infrastructure platforms that are at the end of their useful lives. The

6 source of revenue for this appropriation are income tax funds in excess of the amount from this

7 source that was relied on by the Board of Estimates in determining the tax levy required to

8 balance the budget for Fiscal Year 2023.
