Bmore This Summer: Engage + Connect

- ➤ The Mayor and City Administrator tasked MOCFS and MONSE with co-developing an integrated summer youth engagement plan
- ➤ Bmore This Summer: Engage + Connect prioritizes youth and takes an all-hands-on-deck approach to ensuring their safety
- > The Summer Youth Engagement Plan is one piece of the larger puzzle













Framing The Approach

- ➤ Social development opportunities for young people have been limited since the start of the COVID-19 pandemic
- > We have seen a rise in violence against young people in Baltimore
 - Homicide, non-fatal shooting, and robbery victims under the age of 18 have increased in 2023 YTD
 - Youth violence between 9 p.m and midnight has increased more than 100%













The Plan's Goals

- > Bmore This Summer: Engage + Connect strives to:
 - Provide safe, healthy, and engaging spaces for people under the age of 18 to gather and socialize
 - Provide wraparound/social service supports to children and families in need
 - Reduce likelihood of youth-involved criminal activity
 - Determine root causes for non-compliance with curfew mandate and travel from home distance
 - Provide wage-earning opportunities for young people

Reimagining Delivery

Engagement Model

- MOCFS engaged over 300 young people in a series of discussions across 8 schools and recreation centers to inform the summer youth strategy
- YouthWorks will provide 10 Youth Ambassadors to support rec centers and 2
 Ambassadors to record promotional videos; HeartSmiles will provide training
- This strategy leads with structured out-of-school-time supports and immediate connections to services and resources
- The plan reduces law enforcement engagement; police will not transport youth to engagement centers
- Engagement Staff and social workers will identify any potential needs of youth and their families and connect them to appropriate resources













Transportation

- ➤ The integration of a structured summer programming and curfew engagement plan enables **streamlined resource allocation**
 - Transportation will be provided to youth connection centers and to some programming events
 - Transportation for curfew engagement
 - 4 vehicles (2 per location) will transport youth to the engagement centers.
 - Each vehicle will be staffed by a non-law enforcement driver, a social worker, and a peer ambassador
 - No youth will be transported home by center staff

Staffing

- For **summer programming**, the primary staffing model outlined by each agency lead will be supported by an "all call" from the Mayor and City Administrator to all city agencies for volunteers; and a volunteer plan with community partners
- For **curfew engagement**, the following staffing model will be employed:
 - 10 Offsite Engagement Team Members
 - 4 Drivers
 - 4 Peers
 - 18 In-Center Staff (4 BCPSS social intake; 2 MONSE/MOCFS supervisors; 2 school police; 2 mental health clinicians; 4 engagement staff; 2 BCRP staff - facility leads; 2 BCRP custodians)
 - 3 School Police Officers (locations and curfew engagement areas)

- Youth curfew engagement centers will balance non-punitive engagement with accountability for young people
 - Centers will include age-appropriate spaces and activities
 - Curfew engagement hours: weekends only between 9 p.m. and 3 a.m. until end of school year,
 with assessment
 - Parents/Guardians will receive info at pick-up: calendar of summer programming and punitive consequences for repeated curfew engagements













Engagement For Purposes Of Curfew Management

- Curfew engagement will occur at 3 primary static locations: Inner Harbor, Fells Point, and Federal Hill
- ➤ Additionally, Curfew Engagement Staff will use community info and BPD intel to mobilize as needed in areas where large crowds of youth are gathering
- Transportation vehicles will also travel through neighborhoods to assess where curfew engagement should occur in order to reach young people at most risk of harm or in need of social supports

Post-Curfew Offsite Engagement

- 1. Encounter a youth
- 2. Assess Concerns about neglect/abuse?
- 3. Ask Youth agree to go to center?
- 4. Call supervisor for driving team deployment

BALTIMORE POLICE

DEPARTMENT

- Post-Curfew Offsite Engagement
- 1. Engage with youth
- 2. Assess Concerns about neglect/abuse?
- Call supervisor for driving team (non-law enforcement) deployment

ONSITE CROSS-FUNCTIONAL ENGAGEMENT CENTER STAFF

Post-Curfew Onsite Engagement

All staff will be trained and have a background check

- Child/Youth arrives at center
- Child routed to staff member who checks systems for legal/parent guardian information and initiates contact
- Conduct initial screening and enter data on child/youth input into iPad
- Route child/youth to age-appropriate location within facility
- Emergency contact made Pick-Up
- Capture picture of photo identification/input of information on iPad, and retrieval of child/youth

ENGAGEMENT CENTER TRANSPORTATION STAFF

Post-Curfew Offsite Engagement

- Team arrives and/or identifies the need for curfew engagement
- Social worker and peer ambassador engage
- 3. Ask Youth agree to go to center?
- Discuss what youth can expect around security and engagement
- 5. Document attempt

PARENT/GUARDIAN

Pick-Up

- Arrival, identification of child/youth
 Parent/Guardian must provide valid
- 3. Sign out child on iPad
- 4. Departure



Police Commissioner Memorandum

- After consultation with the Law Department, BPD issued a Police Commissioner Memorandum which includes the following directives:
- Enforcement of the curfew is NOT intended to lead to an unnecessary increase in interactions between BPD and the City's young people.
- BPD will not be taking any information from the youth, transporting the youth or arresting youth for curfew violations.
- The majority of interactions- including transportation to Youth Connection Centers-will be handled by non-BPD city employees or third-party entities.
- Officers will be authorized to make arrests if they observe a criminal action taking place.













Mayor's Comprehensive, Multi-Platform Education And Awareness Campaign

- Mayoral Messaging
 - eBlast, press conference, video, PSA; use of Peer Ambassadors in all recordings/promotions
- Social Media Blitzes
 - MOCFS social media toolkit
- Activation of Youth Voices
 - Youth influencers will amplify messaging; BCPSS Family and Community Engagement Office will provide stipends for youth participation

Data-Driven Decision Making

- ➤ Internal Key Performance Indicators
 - Demographic and programmatic data will be captured daily for all children and youth who come into contact with program staff
 - Youth and parents/guardians will be anonymously surveyed to gauge experience and service levels; staff will also be anonymously surveyed throughout summer
- ➤ Change Management MOCFS & MONSE weekly meeting including programming partners and key staff to discuss KPIs
- ➤ External Evaluation JHU Center for Adolescent Health will complete a process and impact evaluation
