#### **Current Law**

Article VI - Board of Estimates of the Baltimore City Charter

#### § 10. Salaries.

(a) In-term increases or decreases — in general.

(1) In preparing the Ordinance of Estimates, the Board of Estimates may increase or decrease the salaries of all municipal officers, except:

(i) the elected officials subject to Article VII, §§ 117 through 125 of this Charter; and

(ii) the appointed municipal officers who serve as members of the Board of Estimates,

(2) If the salary of an appointed municipal officer is so increased or decreased, it may not again be increased or decreased, as the case may be, during that officer's term.

(b) In-term increases or decreases — Board members.

(1) The Mayor and City Council may, by ordinance, increase or decrease the salaries of the appointed municipal officers who serve as members of the Board of Estimates.

(2) If the salary of an appointed municipal officer on the Board is so increased or decreased, it may not again be increased or decreased, as the case may be, during that officer's term

Dear President and City Council Members,

The Department of Human Resources (DHR) has reviewed City Council Bill 23-0345 – Salary – City Solicitor. For the purpose of establishing the salary of the City Solicitor; and providing for a special effective date.

DHR has reviewed the above-referenced bill and supports the legislation.

The Department of Human Resources reviewed the Baltimore City Solicitor's duties and responsibilities. The City's Solicitor is responsible for serving as the legal adviser and representative of the City and its several departments, officers, commissions, boards, and authorities and has general supervision and direction of the legal business of the City, sole charge and direction of the preparation and trial of all suits, actions, and proceedings of every kind to which the City, or any municipal officer or agency, shall be a party. The City Solicitor position also serves on the Board of Estimates which is responsible for formulating and executing the fiscal policies of the City.

We considered the scope of work, the complexity of the position, the degree of decisionmaking, and technical knowledge to determine the most comparable jurisdictions. The County Solicitor's and the Baltimore City Solicitor's duties and responsibilities are all similar in the nature and scope of work. Below please find a spreadsheet that highlights the salary analysis that DHR did for the City Solicitor Classification. We also included Chief Counsel for Local Education Agencies (LEAs) as the solicitors compete with those legal offices for talent. The City Solicitor and Director of DPW sit in stand-alone classifications and historically their salaries are tracked together because those two classifications can only be adjusted once during their term as they serve on the BoE. The Director of DPW's salary was adjusted to \$245,000 in early 2021 through an ordinance. At the time the DPW Director's salary was \$188,000. Likewise, the Solicitor's salary has been at \$188,000 since at least 2016. The current salary of the Solicitor has also caused compression issues in the Law Department and makes recruitment and retention of attorneys extremely difficult. DHR recommends adjusting the salary of the City Solicitor to \$245,000. This would be commensurate with the salary for other major Cities comparable to Baltimore (see attachment, City Solicitor – Salary Research table).

DHR supports compensation practices which attract and retain a high-quality and diverse workforce. To that end, increasing salaries will allow us to be more competitive in our recruitment efforts and enable us to employ a higher caliber workforce and improve the City's efficiency and effectiveness.
