Major Issues Discussed

- 1. Chairman Costello and President Mosby both gave opening remarks.
- 2. Approximately thirty (30) attendees gave oral testimony; (each speaker was allocated at least two minutes to speak). Some highlighted comments, topics and/or areas of concern were:
 - Water/Wastewater
 - Proper maintenance and equitably distributed is of concern
 - Wastewater Utility
 - o Need to stay in the hands of the City of Baltimore
 - o Is the city's most viable asset!
 - Need to address the aging infrastructure
 - o Hope the city will take a more active role in same
 - ADA Accessibility for the disabled
 - Every place should be accessible!
 - ADA Coordinators are needed
 - Truancy is of concern
 - Chronic absenteeism too!
 - Hope the new curfew will be effective; if not we need to come up with a solution(s)
 - Recreation Centers
 - More are needed
 - More funding is needed
 - Housing
 - More funding needed for renters
 - o \$25 million for emergency rental assistance
 - o \$2 million for housing safety inspectors and inspections
 - o Right to counsel for Renters needed
 - Eviction assistance needed
 - Need eviction protection
 - Is living in unsafe conditions
 - Good inspections are needed
 - Need adequate housing
 - o Housing is Health!
 - Public and private housing funding is needed
 - o There is a shortage/lack of available one-bedroom housing
 - Landlord versus tenant issues are of concern
 - O Do not deserve to be placed on the streets!
 - o Tired of being on the streets!
 - o This budget does not reflect our values!
 - The people of the city deserve safe and affordable housing; inclusionary housing
 - Enoch Pratt Free Library / Libraries
 - Talked about the importance of having libraries
 - Want full funding for same
 - Talked about why funding is needed
 - Needs constant funding

- Need part-time employees to fill-in
- There is a range of things offered by libraries
- The services offered are crucial
- Libraries are a big resource to the City of Baltimore

- Workplace Safety
 - Has gotten so severe
 - Funding is needed to address violations
- Skate Park
 - Is a place to exercise
 - Will give the youth something to do!
 - Have gone from a master plan to now a vision plan Easter wood Skate Park
 - Funding was included in the 2020 budget; what happen
 - Have not seen any plans to suggest the project will move toward
 - o Would like the plan to move forward
 - O Where is the money for the park / Where is the plan!!!

 - o The skate park is for all ages and all walks of life!
