

#### **Baltimore Development Corporation (BDC)**

- 1. The representative from BDC gave a PowerPoint presentation (a copy is on file).
- 2. The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - Commercial Corridors
    - Does BDC have the capacity to undertake more projects for the commercial corridors?
    - Which corridors are you looking at? People do want to open businesses here!
    - o To do more what will it take? Answer: We will research and report back
    - What challenges are your having implementing programs and what can the Council do to assist you?
    - o Have you had any conversations regarding helping residents/communities with starting businesses and/or how to use resources?
      - What are you doing in this area? Talk about this!
        - Such as:
          - Helping community leaders to better understand codes
          - Where to go to gather needed information, and etc.
    - Requested by member Dorsey: Provide the cost per length of roadway, if possible
    - o Policy analysis, is this something I could come to BDC for? For things such as:
      - Increased density
      - Financial gains, community development
      - Real estate, building codes, and etc.
  - Public Market Strategy
    - o What can we do to enhance same?
    - What is being done for getting vendors to fill the stalls?
    - Attracting grocery stores
      - What is BDC during in this area?
      - Do you think we should use more "incentive packages?"
    - Black-owned Businesses
      - More outreach and technology is needed in this area
      - Would like someone from BDC to meet with these businesses
  - Food Markets
    - O How do process a market study to determine which community need a food market? And, especially if its been over 20 years for not having a market in the community!

        - Like to know how matrixes are selected
        - Consistency is of concern
    - Several committee/councilmembers commended Ms. Larsen on her job performance
    - o Budget 101 for Council Members
      - Can we take it a step further next budget cycle?
      - Would also like to have economic modeling tools as well
    - Community Engagement
      - How are you engaging with the communities?
    - o Budget Process New Ability of Council
      - How will you continue to help us with our new ability to move funding around?
      - We will need more time for public feedback
      - Transparency is important to make sound decisions as a Council!
    - o Highway User Revenue
      - In the Executive Summary there was great detail abut revenue and it was very helpful but, I did not see a detailed page for Highway User Revenue
  - Finance Department
    - o New Jobs
      - There are so many vacancies!
      - Requested by President Mosby: Provide an itemized list of new jobs by:
        - Agency and title
        - To include the interagency savings and the methodology for same
        - Including if position(s) are revenue generated
    - o New Procurement Director
      - Concerns: backlogs, city contracts, want to have more competition and less sole sources
    - Mainframe Upgrade
      - Where are we with this? Talk about this
      - Who is the appropriate contact person in Finance to meet with to continue this discussion?

#### o Kirwan Blueprint

- Concerned timeline around the Maintenance of Effort (MOE) for the past year – talk about this
- When did Finance find out about the increase? Talk about the timeline associated with same
- What was the variable that dropped the City under the index?
- Mr. Cenname talked about the calculation and/or formula for how "poor kids" changed. As a result, it effected other jurisdictions with large portions of poor kids.

  - How many payments are still outstanding?
- Tax Sales Reform/Property Tax System
  - Looks forward to working with the Department in these areas
  - Will the timelines change?
- COVID Emergencies / Pandemic
  - Talk about what you have learned from the past pandemic in the event another comes; possible strategies and/or best practices

    - Talk about this
    - Wanted to receive notification regarding this investigation
  - Abandon Property
    - Talk about the new position for this
  - o Environmental Issues
    - What is the possibility of implementing a public health police power? What are your thoughts about this?
  - Reporting Requirements Disclosures
    - Comments regarding same
  - Opioid Crisis/Drug Overdoses

- Do you know where we are going on this issue/crisis? (With legislation?)
- o Police Power
  - Where are we with legislating our own Police Department?
  - What can we legislate and/or not legislate around the Department?
  - Where does the line start and finish?
  - Do you track the Officers who have multiple claims against his/her?
     Answer: No
- Damages to City Property
  - Is interested in stopping crashes
  - Concern: no process in place to get a police report or to get the value of damages to property(s)
  - Recouping money from damages is less than 1%!
  - Per Dorsey, would like to work with the Law Department to get a system in place so we can do better
  - Is it even feasible to go after the money owed?
  - Requested by member Dorsey: As a follow-up, would like for Law and Transportation Departments to get together to iron out what can be done and/or needed to address this issue.
- o Role of the Law Department
  - How does it work? Who do you work for? The advice that is given?
  - Is it for the Mayor?
  - Is it for the Council?
  - What does the "best of interest to the city" mean to the Law Department?
- Legal Awareness/Engaging the Community about what your Department does
  - Are you engaged? Answer: Yes, we absolutely give back!

# Mayor's Office of Minority & Women Owned Small Business (MWBOO)

- 1. The MWBOO Director gave a PowerPoint presentation (a copy is on file). Some highlights from the Presentation were:
  - o Programs
    - Baltimore Main Streets Program
  - Department updates
    - Moving from the Law Department to the Mayoralty
    - Using new software like B2G to track contracts and goals
    - Legislation to expand into additional counties such as Prince George and Montgomery.
    - Looking to expand staff including new compliance and inspection officers.
- 2. The Committee questioned MWBOO Director and Deputy Director. Topics included:
  - Looking at success stories, including youth development programs and micro businesses at locations like Lexington market.
  - Questions regarding the large budget for staff but only allocating for a slight increase from the current fiscal year.
    - This does not include all the staff the department hopes to hire.
  - Cost saving by absorbing other government responsibilities.

- This is revenue neutral. Funds are moving from the Law department.
- Baltimore Main Streets
  - Existing out payments for the current fiscal year.
    - i. Funds are still outstanding going to BOE June 7 hope to distribute funds by June 9<sup>th</sup>.
  - Missed payments have had a significant impact on two of the Main Streets.
  - Chairman Costello noted significant concern regarding the management of the program and its funding which was described as woefully inadequate.
  - A needs assessment have been done for all eight main streets
  - Hoping to distribute funds in one lump sum for next fiscal year 45-60 days into year.
    - i. The Council asked for that to be no later than July 31st.
- Hiring of bilingual staff.
- Contractor accountability.
- o The need for additional funds for business buildout on Greenmount Ave.
- Requested by Chairman Costello: For a commitment that Baltimore Mainstreet Funds for FY2024 be distributed no later than July 31, 2023 and he asked for a meeting with the Interim Director to discuss the Mainstreet Program
- 3. Hearing recessed.

#### Baltimore City Informational Technology/Broadband Digital Equity/Chief Data Officer

- 1. Two PowerPoint presentation were given; one by the Director of BCIT and the other by the Chief Data Officer (Copies are on file). Some highlights from the Presentations were:
  - o BCIT
  - o Streamlining and assessment of staff in the department.
  - Broadband and digital equity initiatives.
  - CCTV camera status and liaising with BPD for their use.
  - New security measures
  - Redesign of web assets
    - Will not include a redesign of the City Council site which is on a separate system.
    - Permit systems.
    - New tax collection system.
    - The 311 Call Center.
      - i. CIO noted working on the closed but not closed issue that has been a problem for residents.
      - ii. Will be adding detailed messages into Salesforce.
      - iii. Adding chatbot for basic information.
      - iv. Adding Spanish to the 311 system.
  - Enterprise Delivery Services
    - Updating security and standardizing infrastructure
    - Equipment for workers in hybrid or remote work.
    - Offered confidential briefing for Councilmembers.
  - Broadband and Digital Equity

- Increasing access and using rec centers, libraries, and senior centers for public internet access.
- Plan is to also pull cable to install public Wi-Fi in public housing.
- Public Wi-Fi is slated to be piloted in the PA and North Ave area in Spring 2024.
- 30,000 Chromebooks for low-income residents.
- 3.2 million in grants for broadband access.
- Chief Data Officer
- o Goal is to use data in city services and governance in the areas of:
  - Operations such as the Collapsed Rooftop AI System
  - Stewardship with programs like Open Baltimore
  - Capacity - with initiatives like the Baltimore Data Academy.
- No general funds for FY 23 Used ARPA monies.
- New process form MPIA request tracking using 311
- 2. The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - BCIT
  - o 311 Center
    - Are surveys being conducted for residents that use the service?
       Answer: Yes, they are
    - How are agencies using the service?
    - Closed does not mean closed.
    - Resolved vs. closed.
    - Why do some service request types not exist in 311 app?
    - Bilingual Services coming in Q2 24.
    - Councilwoman Ramos noted the need for an announcement and rollout.
  - Parking enforcement
    - Councilman Dorsey has been working on an analysis of salesforce/311 in parking enforcement.
    - New salesforce app coming in Q4 2023 implementation.
  - Simultaneous translation services for public meetings and hearings
    - This is also an ADA issue as well.
  - Permits
    - Please include DPW in notifications about permits.
  - Digital Equity
    - ISP to compete in July for contract for Wi-Fi service.
    - Access in the Fallstaff neighborhood using the parks may be a solution to no rec centers.
  - City website update
  - ARPA Funds
  - Chief Data Officer
  - Open Check Book
    - Has not been updated in two years.
    - Paused by the Workday Implementation.
    - No associated cost with the software.
  - Increase of data sets for reporting
    - Includes lobbyist registration, tax sale, and GIS data.

- o June 30th Open Baltimore report is due
- City website update
- o Comcast franchise agreement
  - Up in 2026
  - How can more competition be brought to Baltimore.
  - Update on preparations for negotiations with Comcast
- o Requests:
  - For a timeline for when a notes function and other updates to the 311 Center will be available
  - That the Department look into funding allocations for translation services
  - A timeline for updating Open Checkbook
- 3. Hearing recessed.

#### Department of Public Works

- 1. The committee/council members asked questions, stated concerns, asked for clarification, and etc. Some highlights of same were:
  - o Service 671 Positions
    - The positions changed from 26 to 16 in Administration, why?
    - Is there a change in functionality?
  - Weekly Curbside Workers
    - Someone said Solid Waste does not know what they need! Is this true?
  - Clean Corp Program
    - Are you considering expanding this program? Answer: Deferred to Planning Department
  - Street Sweeping
    - Some streets are not being swept what is going on there?
    - Some lanes have not been swept due to bike lanes, is this true? Answer: Yes
      - i. Per DPW the "white flex poles" are a deterrent to sweeping streets
    - The enforcement for folks who don't move cars on applicable days talk about this
    - Do you have the capacity to determine which streets receive mechanical street sweeping?
    - Is street sweeping happening on every street every month?
    - Requested by member Schleifer: Provide an up-to-date map for all street sweeping routes in his district
    - Parking citations in violation of mechanical street sweeping, is there a process where a citation is given and afterward someone may want to abate same (a recourse)?
      - Requested by Chairman Costello: Asked Finance Department to look into abating citations in cases when street sweeping did not occur, due by September 2023
  - Compost Facility
    - We are now three (3) years into a ten (10) year plan!

- What is the status of the compost facility; regarding phase one development?
- Transfer Station(s)
  - Where does the revenue go? Answer: General Funds
  - Requested by member Glover: Provide how much revenue these stations general in a year
- Water Billing / Water Accountability Act
  - Inaccurate water billing is still a concern
  - How much more money is needed to get this right?
    - i. This is a big problem; especially for older adults!
- Service 675 Residential Inspections for Water Projects
  - Concern: Quality assurance for those inspections is needed!
  - The inspectors assigned to the Hampton/Ashburton areas need training!
  - Requested by member Torrence: Provided the following:
    - i. Current training for inspectors in both the Hampton and Ashburton areas
    - ii. Traffic mitigation, and
    - iii. Damage Reports
- Water for All
  - Is the discount once a year or once a month? Talk about this and how it is applied
  - The credits given, is it based on income status? Is it treated as income or as a gift?
  - Requested by member Ramos: Provide in writing the law pertaining to the Water for All Program
  - Water Rate Increases
    - i. Talk about this for the City and County
    - ii. Talk about the processes for same
    - iii. How do we receive revenue from the County?
- Ashburton Water Project
  - Talk about the deadline associated with this project
  - Requested by member Burnett: Provide follow-up updates on a quarterly basis; first report due by June 30, 2023
- o Concerns:
  - Sidewalks unrepaired for years
  - Patchwork/Resurfacing
  - Concrete repair work
  - Is looking for ways to get these things done and to address the backlog as well
  - Comprehensive and sound review of every project performed are needed
  - Crews are walking away from projects and never returning!
  - Is looking at how much money you are spending on contractual services!
  - Requested by member Dorsey: Asking DPW to go out and look at Swansea Road in his district to see if it needs to be fixed/repaired!

- Permit Administration
  - Who is the contact person for same?
  - Why isn't DPW permitting in the same system as DHCD? Why are they in separate systems?
- Collaboration between DOT and DPW is of concern
  - sound and effective communication needed
  - taking clear ownership of responsibilities needed
- What is the restoration timeline for repairs?
- There has been much escalated costs since the Pandemic, how can we address same?
  - And it has had a tremendous effect on construction work!
  - Past behavior of some contractors is of concern, how will you address same?
  - Requested by member Torrence: Would like to be briefed on past performance of the contractors who have performed bad work
  - Requested by Chairman Costello: Provide a written narrative for the policy you use for repairs; to include information regarding DOT street cut policy
- Safety of DPW Workers
  - What in your budget did you ask for to address this issue?
  - Delivering effective services is critical!
  - Issues have not been taking seriously by agencies!
  - Department is not at the level of prevention!
  - More safety inspections are needed
  - Site line Supervisors need to know that standards are going up!
  - How are you going to communicate the need and importance of the safety of the workers?
- Complete Streets Ordinance
  - Concern: That streets are repaired and restores in a better condition!
  - Would like to see DPW work out a step-by-step progress plan for completing repairs, roadways and projects!
  - Another water project is coming up in the 14<sup>th</sup> district!
    - i. Some of the streets in district were just beautifully resurfaced and we do not want them cut up again!
    - ii. If they are, it will be a huge neighborhood protest!
- Community Outreach
  - What are you doing in this area?
  - What are you doing to help fill vacancies?
  - How can we put more city residents to work?
- O Do you have a Spanish speaking liaison?
- Capital Projects for Sewer and/or Water
  - Are quality controls in place?
  - Concern: Effective utility work
- Property Maintenance
  - Are we using any different type of materials to board up vacant buildings?
  - Want to make sure homeless people are not and/or can't get into them
  - Do you use cement and/or cement blocks?

- i. Concern: To figure out ways to reduce costs
- 2<sup>nd</sup> Floor Level of Rowhouses
  - i. Is there any conversation regarding changing the policy for same
  - ii. Turning water off in vacant buildings is of concern; why is this not happening?
- Frequent flyers on properties, how do you address this?
- o Zero Waste Initiative
  - Have the study been completed? Answer: No
- o The Ten (10) Year Solid Waste Plan
  - Talk about what is in the Plan
- o Bresco
  - Bresco is scheduled to end, talk about this
  - Is looking forward to looking at the new plan in depth! What are some of the things to be included in the Plan?
  - Concern about meeting timelines
- Weekly Trash Collection
  - Last year weekly trash collection did not start
    - i. Recycling efforts has dropped significantly since 2017
    - ii. Recycling was down by 43% according to a spreadsheet submitted by DPW
    - iii. How much savings were there? Answer: None because overtime and fatigue costs went up. We need to hire more crews and get the vehicles needed
    - iv. Currently, how many households on average are recycling weekly?
    - v. Trash Cans
      - 1. Prior to you rolling out those cans we had a conversation stating it would be a mistake to do so!
      - 2. The decision to roll out those cans is why things are the way they are!
      - 3. Was the timing associated with the roll-out of bins a mistake? Answer: No
  - Requested by member Schleifer: Provide an itemized list for why there is no savings to include a "hard date" for when weekly recycling will start. Also, provide the contract for the roll out of the bins/trash cans
- Sanitation Workers
  - There is an increase in administration costs but not in salaries for the sanitation workers!
  - Concern: DPW pay scale; some are getting paid very well but not the sanitation workers!
  - How much pay increases did the laborers working in trucks get during the past year?
  - When did they last receive pay increases?
  - Requested by member Schleifer: Provide in writing a total for the "reclassified positions" that make over six (6) figures

- Are any of the employees who make over six figures allow to work remotely for an extended period of time? Answer: No, none
- o ARPA Funding
  - Did DPW receive any ARPA funding? Answer: Yes
  - How much ARPA funding did you request? Answer: \$270 million was requested but received \$15 million
  - Requested by President Mosby: Provide an itemized breakdown for the ARPA funding you received
- Projects Completed on Time
  - The percentage for same looks to be below standard
    - i. How do you set this target?
    - ii. Talk about what's going on here
- o Lead Based Pipes, how are you assisting homeowners with abating the lead?
  - Have you applied for State assistance for same?
  - Requested by member Torrence: Provide by September 2023, the funding amount for assisting homeowners who want to remove leadbased pipes
- Wastewater Backup Increases
  - This information was in the budget since 2017; why did you remove it from this budget?
  - Requested by Burnett: Provide the expenditures for the SOS/Cleanup Program; to include the number of wet and dry weather backup data
- Hiring for Consumer Advocacy and Customer Appeals
  - It is supposed to be an Oversight Committee talk about this
- Vacancies
  - How many crews were available in FY 2023 for Solid Waste?
  - How many are staffed currently?
  - What is the expectation for what will be budgeted in FY 2024?
  - What are your strategies for filling vacancies?
  - What are your expectations for recruitment and retention?
  - Hiring and Retention is of concern
    - i. Do you know what the retention rate is?
    - ii. Do you conduct surveys and know why people are leaving?
- O Does DPW have a Succession Plan?
  - Is there a way to take a snapshot "quantitively" of your succession plan?
- Small Businesses
  - What are you doing to unbundle some of the larger contracts for small businesses? What are you doing here? Talk about this
  - We need innovative ways for Bonds to promote small business and women owned businesses, are there any?
- Workload/Backlog/Vacancies
  - Who can you hire to provide work for city? What is the process?
- Clean Corp Program
  - Do you hire people who are associated with the program?
- Technology for Route Optimization
  - Talk about this, what was the increase for same?

- i. Is this a one-time increase? Answer: No, a yearly cost for the software
- Biowaste Consultant Talk about this
- o Do you plan to use the same vendor for cleaning encampments?
- o Patapsco / Back River / Waste Water
  - Where are you with improving staffing?
  - What are your vacancy rates for Patapsco, Back River and Waste Water?
- Director Mitchell's Position
  - Where are we with Director Mitchell's replacement?
  - What is the plan to maintain the culture within the Department?
  - Have seen much improvement within the Department under the direction of Director Mitchell!
  - Several committee/councilmembers thanked Director Mitchell for his job performance
  - A member stated, "We want you to stay."
- o Inlet Cleaning and Inspections
  - There are over 52,000 inlets
    - i. What is the process for cleaning and inspections? How does it work?
    - ii. Concern: Flood areas
- Illegal Dumping
  - Lost tickets and/or citations is of concern
    - i. What are we doing to close the gap between DPW and DOT to addressing this issue?
    - ii. Direct collaboration is needed between the two (2) agencies
- E.coli Outbreak
  - Can you clarify if DPW met the public notification requirement?
     Answer: Yes, DPW met the requirements
