  - ii. Asked about the timeline for the study.

- 6. Chairman Conway asked for a motion to adopt the amendments.
  - a. The amendments where unanimously adopted.
- 7. Chairman Conway asked for a motion on the Bill.
  - a. The Bill was approved with the amendments unanimously.
- 8. The Bill moves to 2<sup>nd</sup> reader.
- 9. Chairman Conway recessed the hearing.
