Re: American Rescue Plan Funds – Performance Oversight Council Bill 21-0121 Monthly Report

Background

This memorandum accompanies the City of Baltimore Mayor's Office of Recovery Program's submission of its monthly report to the City Council on spending and performance related to American Rescue Plan Act (ARPA) funding. Specifically, Council Bill 21-0121 § 49-2(B) prescribes the elements of legislatively required reporting, which stipulates that monthly reports should:

- 1) Provide data and metrics regarding how the funds have:
 - I. Increased the effectiveness of city government services;
 - II. Broadened the reach of city government services;
 - III. Made city government services more efficient;
 - IV. Made city government services more sustainable
- 2) Identify key performance indicators, benchmarks, and targets related to:
 - I. Equity, as defined in Article 1, § 39-1 of the Baltimore City Code;
 - II. Population Growth;
 - III. Labor and Employment;
 - IV. Economic Growth, especially the growth of minority and women-owned businesses; and,
 - V. Community Benefit

Commitments and Expenditures

At the end of December, the Mayor's Office of Recovery Programs has committed \$641.1 million in ARPA funds to City agencies, quasi-governmental organizations, and nonprofits to advance priority initiatives for the benefit of Baltimore City residents. Through December 2023, about \$183.4 million dollars has been spent on ARPA-funded projects (See Table 1), accounting for about 29% of the current commitments and of the city's \$641M total ARPA allocation.

Commitments

Table 1 lists ARPA commitments totaling \$641,170,126, the full Baltimore City ARPA allocation. Expenditures total \$183,389,585 through December 2023.

Recovery Office Accomplishments

The Mayor's Office of Recovery Programs directly awarded ARPA funding to 45 nonprofit organizations. As of December 2023, all 45 nonprofits have received disbursements totaling \$23.5 million. See Table 1 for information on total disbursements to nonprofits. In addition, some highlights of select nonprofit activities in December are as follows:

- Banner Neighborhoods had their largest Workforce Program workshop enrollment of 43 students. Youth participated in a Budgeting Reality Fair where they were given a family situation and budget. They were then tasked with finding health insurance, childcare (if applicable), ways to donate, food, transportation, and clothing for their family situations.
- Green & Healthy Homes Initiative (GHHI) added an additional Client Intake Specialist, Environmental Health Educator and Hazard Reduction Worker to the Program during the reporting period. GHHI hired a second Baltimore City resident for the Hazard Reduction Worker position and is committed to hiring other Hazard Reduction Workers and program personnel from at risk, disadvantaged communities in Baltimore City.
- Leadenhall Baptist Church's Pantry Program was approved as a Network Partner with the Maryland Food Bank and hosted a Pantry on the Go food distribution event on December 19, 2023. Leadenhall is currently preparing to host the Southwest Baltimore City Regional Maryland Food Bank Gathering on February 14, 2024 and another Pantry on the Go food distribution on March 19, 2024.


In addition, the Recovery Office continues to provide technical assistance to all funded city agencies, quasi government agencies and nonprofits as well as coordinating with centralized functions such as legal, procurement and finance to facilitate timely disbursements and expenditures.

Subawardee Accomplishments

Economic Recovery Fund

There have been 1,063 grants awarded, totaling \$19,289,287, from Economic Recovery Fund fiscal agents to beneficiaries, including nonprofits and small businesses (See Appendix for a complete list of organizations). Four out of five fiscal agents have completely disbursed grant funds. The fifth fiscal agent—Baltimore Development Corporation (BDC)—continues to disburse grants to its subrecipients. The map below indicates the location of all organizations funded by BDC through December 2023. A map including the locations of other Economic Recovery Fund recipients can be found on the Recovery Office dashboard.

Baltimore Development Corporation (BDC) Economic Recovery Assistance

BDC processed a limited number of first and second checks – totaling 35 checks (12 second checks to Round 1 awardees, 8 first checks to Round 2 awardees, and 15 second checks to Round 2 awardees). BDC continues to coordinate with businesses in Round 2 to gather and authenticate the necessary documentation to issue checks. BDC is also coordinating with businesses on eligible uses of grant funding, as some businesses' needs have changed since submitting their application for funding. BDC is also in the process of coordinating with the Recovery Office to review expenditures, budgets, and performance of the Technical Assistance partners in the BASE Network.

City Agencies Accomplishments

Baltimore City Recreation and Parks (BCRP)

The informal bid for the Gwynns Fall trail project has been issued by the Bureau of Procurement after significant delays. The Towanda and Coldstream solicitation packets have been reviewed by the Law Department and were publicly posted. Bids are due on February 21, 2024. Fifteen of the remaining 16 playgrounds have been approved with Purchase Orders. The last one, Dewees, is in processing. The Gardenville Recreation Center solicitation went out to bid in December 2023, and bids were due on January 24, 2024.

Baltimore City Health Department (BCHD)

The Politics with Purpose contract was approved and work with the vendor is beginning on the communications campaign.

VALUE Community leads attended 27 events in December and have 17 events scheduled in January 2024. At these events, VALUE Community leads promote vaccination clinics through educational outreach and provide information, not only on Covid, but other underlying health conditions to emphasize the importance of Covid-19 vaccination.

Baltimore City Information & Technology (BCIT)

New Computers and Technical Equipment for City Employees

As of this current reporting period, 54 Citiwatch cameras have been deployed. There are 12 meeting rooms currently being converted into hybrid rooms. BCIT's Hardware Refresh allocation includes \$700,000 in funding to replace switches, hubs and access points that support Baltimore City government's network infrastructure. Procurement has begun for this project, as BCIT placed an order for roughly \$575,000 worth of equipment in December using existing contracts.

Broadband and Digital Equity

Next One Up (NOU), a Digital Equity Fund (DEF) grantee, has delivered digital literacy programming to 100 middle and high school students who are participating in out-of-school time programming. Throughout the months of November and December, middle and high school participants have joined in programming designed to bolster foundational digital literacy skills and to impart higher-level knowledge around 3D printing, including coding and digital. These lessons incorporate discussion of workforce pathways and careers in related fields. In addition, since September 2023, the NOU Base Camp has been open in Belvedere Square. It provides reliable access to fast, secure Wi-Fi for all members of the Next One Up community—nearly 190 young men and their family members. Young alumni have accessed the space to use the WIFI for telework, filling out job or college applications, and other activities.

Open Works, another DEF grantee, has successfully installed two solar stations for Wi-Fi use in the community as of Dec. 6, 2024: the 29th St. Community Center in Harwood and the Nate Tatum Center for Strong Boys and Girls in Barclay. As of the end of December, the team has ordered or received parts towards the completion of the next 6 solar stations.

Mayor's Office of Employment Development (MOED)

Seventeen Train Up Occupational Skills training providers continue to provide services, including seven funded by City ARPA. During this reporting period, additional City funding is being allocated to ten previously State-funded Train Up agreements. All Support Services and Community Connectors contracts are also in place and services continue. In total, including City and State funding, Train Up has enrolled 1,030 residents in training, of whom 443 are with City ARPA-funded programs. So far, 331 participants have earned one or more industry-recognized

credentials. While a total of 50g enrollees have completed training, many are still in training, working towards their certifications, and receiving job search services. MOED has logged 267 of the reported job placements, with additional job placements reported and logged monthly. Training graduates that have not yet gained employment continue to receive job placement supports. The average wage to date is \$19.08 per hour, well above the target of \$15.00 per hour and minimum wage.

A total of 290 unemployed or underemployed Baltimore City residents have received subsidized employment through Hire Up. Of these, 177 are funded by City ARPA. Including State-funded participants, One-hundred and 10 (110) of those who remained in the program at least two weeks have transitioned to unsubsidized employment, 101 of whom reported an entry wage of \$16 an hour or higher. MOED has developed partnerships with the following worksites: the Baltimore City Department of Transportation, Department of Finance, Baltimore City Recreation and Parks Department, Department of Public Works, Parking Authority of Baltimore City, Downtown Partnership of Baltimore, Baltimore City Health Department, and the Mayor's Office of African American Male Engagement, and the Mayor's Office of Neighborhood Safety and Engagement. MOED also serves as a worksite.

Hire Up and Train Up Project Managers continue to coordinate with two legal services providers, Maryland Legal Aid and Maryland Volunteer Lawyers Service as well as Associated Catholic Charities to provide behavioral health services. To date, at least 538 participants have taken advantage of free legal services and 412 participants have received group or individual behavioral health services.

The Wage Subsidy to Small, Minority- and/or Woman-Owned Businesses has been very successful. MOED has fulfilled 45 subsidies funded through the first round of State ARPA funding, 205 subsidies with City ARPA Funds, and the remaining 180 subsidies with State II funds. In total, just over \$2.7M of MOED's ARPA funds were invested to support COVID recovery for 188 Small, Minority and Women-Owned Businesses and 460 unemployed and underemployed Baltimore residents impacted by COVID were hired because of this investment. Based on survey results, beneficiary employers reported 10-week retention rates of 96% and 6-month retention rate of 80% with an average wage of \$21.53 per hour. Seventy percent of the beneficiary businesses stated that they reinvested the subsidy to raise salaries and hire more people.

The Let's Ride to Work program has resumed utilizing second phase State ARPA funds. MOED is working on contracting the third round of funding, which will be funded by City ARPA, directly with a rideshare provider. Through the end of this reporting period, 413 newly employed Baltimore residents have taken advantage of 13,710 free rides through this program. Ninety-four percent of post-survey respondents have rated the program as "Very Helpful," and 46 of 53 survey respondents (87 percent) reported still working at the time they completed the survey.

Mayor's Office of Homeless Services (MOHS)

The Mayor's Office of Homeless Services has fully launched the Landlord Incentive and Flex Fund which will assist in ongoing efforts to decrease the length of time individuals remain in crisis waiting to return to permanent housing. The Housing Accelerator Fund's Notice of Funding Availability (NOFA) has been finalized and is in the process of application review. The project is a collaboration between DHCD and MOHS to provide nearly \$30 million in ARPA and HOME-ARP funds in developer incentives for permanent supportive housing and traditional affordable housing.

Mayor's Office of Neighborhood Safety and Engagement (MONSE)

Victim Services

Throughout the holiday season, MONSE and its network of community partners helped facilitate several festive gatherings. On December 16th, Let's Thrive Baltimore hosted its 7th annual Christmas party at MONSE's West Baltimore headquarters, where over 300 children and families gathered for an afternoon of food, celebration, toy giveaways, and more.

The first interagency victim services coordinating council meeting is scheduled to kick off in mid- to late-January and will convene on a bi-weekly basis. MONSE will also be meeting with colleagues at MOCFS and Department of Juvenile Services (DJS) to improve supports for individuals exposed to violence. Specifically, MONSE will be seeking ways to enhance interagency coordination and support following a DJS referral, ensuring that individuals have easy access to tailored wraparound services and trauma-informed support.

Coordinated Neighborhood Stabilization Response (CNSR)

In December MONSE closed out its 45-day proactive stabilization in Edmonson Village. Throughout the stabilization period, MONSE staff engaged with at-risk youth in the shopping center, collected contact information and helped individuals get connected to various supportive services. For example, during the final days of the stabilization, MONSE successfully delivered daycare vouchers for the nephew of an individual who identified daycare as an urgent need for his family. Following the 45-day proactive stabilization in Edmondson Village, MONSE is set to begin another 45-day proactive stabilization in nearby Walbrook Junction, which continues to face many of the same challenges regarding high-risk youth. The stabilization is scheduled to begin the week of January 8th and will build on many of the best practices and lessons learned from Edmondson Village. Additional updates will be detailed here in future reporting.

Additionally, on December 20th, MONSE and Center for Hope hosted a holiday toy giveaway for the Brooklyn community. Over 300 attendees passed through the Brooklyn Community Center between 5-8pm that evening, leaving a bright ending to close out MONSE's extended sixmonth stabilization.

Community Violence Intervention (CVI)

There are currently 31 open positions across all Safe Streets sites. To date, 98 applicants have been accepted and submitted for first-round vetting, with 43 applicants approved to advance for a second round (an additional 30 candidates are also currently being considered for second-round vetting). MONSE, its CBO partners, and Safe Streets leadership are dedicated to ensuring that every prospective candidate is thoroughly vetted and best represents the ideals of this critical work.

To help kick off the new year, MONSE is scheduled to begin its 12-stop CVI listening tour in communities across Baltimore. The listening tour will provide a unique space for community members, local leadership, and city agencies to come together around a shared goal of improving public safety and support for both victims and perpetrators of violence. In addition, MONSE and the University of Baltimore will be taking steps to grow its CVI ecosystem with the inaugural rollout of its conflict mediation certification course. This 8-week program will be conducted across 10 day-long sessions and is designed for groups of approximately 50 participants. Topical areas will focus on themes of mediation, trauma-informed care, conflict de-escalation, and intergroup dialogue, among others. The program will operate within and for the benefit of neighborhoods disproportionally effected by violent crime in Baltimore City.

Re-Entry

On January 11 at 5pm, MONSE hosted an introductory re-entry council meeting with community partners PIVOT, HOPE, Baltimore Children and Youth Fund, New Vision House of Hope, and returning citizens who expressed interest in the council's work. This council will serve as an advisory board to help oversee planning and implementation of the Returning Citizens Behind the Wall (RCBTW) program. This initial meeting will provide an opportunity for community partners and individuals to meet and discuss best practices and/or strategies designed to increase buy-in from prospective participants. Meetings will be held every third Thursday of the month, whether virtually or in person. The mission of RCBTW is to ensure that returning citizens have access to the supports, training, and resources they need to regain stability on the outside. Accordingly, on January 18th, MONSE's Re-Entry Coordinator went behind the wall with select colleagues from the Mayor's Office of Employment Development (MOED) to elicit more buy-in from individuals preparing for release. Information and insights collected during this visit will be used to inform future re-entry council discussion around participant need, perceived and/or objective barriers to participant success, and next steps for implementation.

Group Violence Reduction Strategy (GVRS)

After weeks of intense logistical planning, the Mayor's Group Violence Reduction Strategy expanded into the Central District in the second week of January. This latest expansion will build on the strength and continued success of the GVRS strategy, as evidence by the fact that in 2023 Baltimore experienced its largest year-on-year drop (~21%) in homicides in half a century. These promising trends can't absolve the fact that 259 Baltimore City lives were lost to gun violence last year, and MONSE was privileged to participate in the reading of their names as part of the Mayor's annual Vigil of Remembrance on January 3rd. On January 19th, a press conference was held to discuss the upcoming expansion and UPenn evaluation of GVRS.

Mayor's Office of Immigrant Affairs (MIMA)

Baltimore New Americans Access Coalition (BNAAC)

In December 2023, MIMA began conducting desk audits for three of the four implementing CBOs, MIMA anticipates this process will conclude in January 2024, As a result of these desk audits, Esperanza Center has initiated its own internal desk audit process and has begun to build a better system for more frequent casefile review, including weekly review to ensure accurate data is entered into the database and monthly review to assess for quality, MIMA will encourage this practice to other implementing partners. LIRS coordinated an individualized SNAP application training for Esperanza Center, the OHEP Critical Medical Needs training and completed on-boarding training for recently hired benefit navigators by providing the BNAAC go Day and 180 Day case closure trainings.

In the month of December BNAAC attended several events and had information tables at the Barangay Baltimore Coat Drive, Older Adults Summit, Greater Urban League Resource Fair, St. Vincent DePaul HeadStart Holiday Party, the Salaam Christmas Party. As well as shared BNAAC information at the Judy Center Steering Committee Meeting and Comité Latino Meeting. In the next month, BNAAC plans to implement weekly outreach to partner sites including City of Refuge, IOSC, the Franciscan Center, and the St. Vincent DePaul HeadStart. Planning is happening around having an event cohosted between BNAAC Esperanza Center and the St. Vincent DePaul HeadStart to share information with the over 60 Limited English Proficient families enrolled in their services.

Language Access

In December 2023, MIMA began working with Xcelerate Media. Inc. to develop 2 e-learning courses for Language Access. The first course is a brief 5-minute "learning commercial" that can be shared widely as an overview of language access policies. The second is a 15-minute

interactive module that will be uploaded in Workday. The training will cover important language access policies and information on how to access language assistance services for City employees. Additionally, MIMA began working with Wide Angle Youth Media to develop branding and design materials for Language Access outreach.

In December, MIMA published its annual year in review, which was sent to a list of nearly 8000 community partners and was posted on MIMA's social media pages. The Year-In-Review highlighted Language Access work that has been accomplished this year, including the number of staff trained and the different languages encountered by City agencies.

Department of Housing and Community Development (DHCD)

DHCD – Impact Investment Areas

The Impact Investment team have successfully hired an appraisal reviewer to assist with eliminating the bottleneck for appraisal reviews that are required for each acquisition. During this last period of performance over 200 properties were identified for acquisition.

DHCD- Permitting System Upgrades

The Permitting System Upgrade team has successfully completed the Pre-Tailoring System Configuration, Data Conversion Source Inventory, Core Team Training, and Project Management Plan which are critical phases required for implementation. The tentative target for launch remains winter of 2024.

DHCD – Park Heights Infrastructure and Senior Housing

The Groundbreaking for the Park Heights Senior Affordable Housing Project took place on December 11, 2023. The project that also includes major improvements and upgrades to existing infrastructure will feature 100 affordable senior rental units, 53 affordable multifamily rental units, and 17 affordable homeownership units.

Department of Planning (DOP)

Online SNAP

The Department of Planning has seen an increase in incentive redemption for their online SNAP incentive program. Amazon joined in August and in October and the team saw the highest number of incentives redeemed to date due to their participation in the program. Additionally, progress is being made in regard to communications and marketing to promote B'more Fresh more widely. The team has hosted their first Resident Food Equity Advisor meeting in November, and participants of the cohort will be serving as online SNAP advisors. Additionally, the Mayor is planning on speaking about the program publicly via social media. DOP also received USDA Food and Nutritional Service approval to cover delivery costs and are working with retailers to implement.

Produce Box

The produce box distribution teams have completed produce box site visits in December 2023. These meetings provided valuable insights and feedback from produce box partners which will be converted into a summary report in 2024. Produce boxes were distributed to resident food equity advisors, who were able to provide a healthy addition to their weekly menu.

Farmers Markets

The farmers market season for main e-incentives farmers market partner, Agrihood Baltimore, wrapped up this quarter. Currently, discussions are being had with the two large City Farmers Markets, 32nd Street and The Baltimore Farmers Market, to transition their markets to the e-incentive platform for the 2024 season. The challenge remains farmer and vendor buy-in to switch to the new technology. The team continues outreach to farmers markets in the city who currently do not participate in the e-incentive program. Additionally, the e-incentives

coordinator has been working with the City's Department of Aging to provide nutrition benefits training and resources to their staff and the seniors they serve.

Produce RX

The Food Rx participants were invited to a cooking class at the American Heart Association's Healthy Cooking With Heart kitchen. The four participants prepared a heart healthy meal, high-fiber. plant-based meals using ingredients commonly found in the Food Rx pantry, and the class was a tremendous success. Class participants expressed that they enjoyed the experience and were looking forward to future classes. Staff in attendance noted how exciting it was to see the class participants try and enjoy new foods.

Department of General Services (DGS)

Baltimore Police Department (BPD) Fleet

DGS has received 52 of the BPD Police Interceptor Utilities ordered using ARPA funds. The remaining 48 BPD Police Interceptor Utilities (PIUs) are estimated to be delivered in mid-2024. Upfitting has begun for the 52 vehicles received to-date.

Department of Public Works (DPW) Load Packers

DGS fleet has received nine (g) ARPA-funded load packers. These units are being upfitted, tagged, and labeled.

HVAC Improvements at City Libraries

In the past month DGS and Rife International have finalized the overall design-build cost for the six (6) libraries that are part of the Enoch Pratt Free HVAC Repair Project. An agreement between DGS and Rife has been written and sent to Rife for signature. The agreement will go before the BOE in March.

Capital Improvements

Bids for the Northwest Community Action Center project have been received. The award for this project will be on the BOE agenda in February. The City Hall Roof project was advertised for bid on January 26, 2024.

Department of Public Works (DPW)

Waste Removal

DPW is utilizing \$3,285,000 in ARPA funding to cover a contract for Spindler Refuse Service, Inc. to provide residential trash and recycling hauling for one year in order to help return to weekly recycling services. The contract will end October 31, 2024.

Recycling Crews

On December 6, 2023, thirty (30) ARPA-funded recycling crew positions were approved for DPW by the BOE. DPW has been able to expedite the hiring process for the ARPA funded positions of drivers and labors. Recruitment will continue and staff that has been hired will begin in January and remain funded by ARPA through June 30, 2024.

Capital and Operating Improvements

On December 1, 2023, DPW signed an interagency with the Recovery Office for \$5,659,780 to utilize ARPA funds for capital and operating improvements. Capital improvements will allow for more sanitary conditions for DPW staff. Capital improvements include facility upgrades at various locations. Operating improvements include the purchase of new technology such as routing software and tablets, as well as larger equipment including mini-load packers, tractors, and bobcats.

Performance Measures and Metrics

A select number of performance measures are included in Table 3. Measures should not be viewed as underperforming since many programs or data collection are just beginning. The Recovery Office will continue to coordinate with subrecipients on measure accuracy. Additional data on performance measures will be included in Council reports as programs are further implemented, and data becomes available. Other performance measures can be found on the dashboard.



American Rescue Plan Quarterly Oversight Hearings

FOR the purpose of calling for quarterly budget oversight hearings regarding the disbursement and management of \$641 million in federal funding to the City of Baltimore through the State and Local Fiscal Recovery Fund to improve transparency and accountability for the pivotal task of responding to the economic impact of the COVID-19 pandemic.

Recitals

8 The COVID-19 global pandemic has had devastating economic consequences – pushing 9 individuals and families further into poverty, hurting local economies, forcing families to make 10 tough decisions regarding their basic needs, and straining the budgets of local governments. 11 American Rescue Plan ("ARP") funding can help stabilize local businesses, provide critical 12 investments, and address systemic inequalities. These funds represent a historic opportunity to 13 support the City's efforts in addressing historic inequities and promoting inclusive economic 14 growth.

Therefore, these funds must be spent equitably and prudently to improve the lives of
historically neglected communities in Baltimore City and residents most impacted by COVID-19.
It is the duty of the City Council to ensure that the community is aware of what investments
federal funds are supporting and how funds are being used to support vulnerable City residents.
Through ARP funding, the City has the opportunity to address long-time challenges and
disparities that have been exacerbated by the ongoing COVID-19 pandemic.

The Council must ensure that information is made publicly available regarding how ARP 21 funds are being spent, how many jobs are being created or preserved through the use of the funds. 22 where investments are being made, and how the funds are advancing equity and addressing 23 systemic inequities. Quarterly oversight hearings will help ensure that the Mayor's Office of 24 25 Recovery Programs, agency charged with the City's recovery-plan spending, clearly details the goals of ARP expenditures, allocates funds to projects that alleviate the negative economic 26 27 impacts of COVID-19, addresses inequities, administers funds in a timely manner, dutifully tracks spending, and provides spending statements to the public. 28
