AN ORDINANCE CONCERNING

1 **Supplementary Special Revenue General Fund Operating Appropriation –**
2 **Department of Public Works – \$5,982,755**

3 FOR the purpose of providing a Supplementary Special Revenue General Fund Operating
4 Appropriation in the amount of \$5,982,755 to the Department of Public Works – Service 663
5 (Waste Removal and Recycling), to provide funding for unbudgeted contractual collection
6 services and tipping fees beyond budgeted amount; and providing for a special effective date.

12 **Recitals**

13 The revenue appropriated by this Ordinance represents \$5,982,755 in excess of the revenue
14 relied on by the Board of Estimates in determining the tax levy required to balance the budget for
15 Fiscal Year 2024.

16 This additional revenue could not have been reasonably anticipated when the Ordinance of
17 Estimates for Fiscal Year 2024 was formulated.

18 ~~The source of this additional revenue is Income Tax - State Collected.~~

19 This appropriation is made necessary by a material change in circumstances since the
20 Ordinance of Estimates for Fiscal Year 2024 was formulated or is for a new program that could
21 not have been reasonably anticipated when that Ordinance of Estimates was formulated.

22 On February 5, 2025, the Board of Estimates recommended this appropriation to the City
23 Council.



1 **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That
2 \$5,982,755 shall be made available to the Department of Public Works – Service 663
3 (Waste Removal and Recycling) as a Supplementary ~~Special Revenue~~ General Fund Operating
4 Appropriation for Fiscal Year 2025, to provide funding for unbudgeted contractual collection
5 services and tipping fees beyond budgeted amount. The source of revenue for this appropriation
6 is Income Tax - State Collected in excess of the amount from this source that was relied on by
7 the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year
8 2024.

9 **SECTION 2. AND BE IT FURTHER ORDAINED,** That this Ordinance takes effect on the date it is
10 enacted.
