AN ORDINANCE CONCERNING

1                                   **General Fund Operating Appropriation Transfer –**  
2                                   **M-R Debt Service (Service 123 - General Debt Service) to**  
3                                   **Office of the Sheriff (Service 882 - Deputy Sheriff Enforcement) – \$4,564,341**

4       FOR the purpose of transferring a General Fund Operating Appropriation in the amount of  
5       \$4,564,341 from M-R Debt Service (Service 123 - General Debt Service) to the Office of the  
6       Sheriff (Service 882 - Deputy Sheriff Enforcement); and providing for a special effective  
7       date.

13                                   **Recitals**

14       Article VI, § 9(a)(2) of the City Charter provides that, on recommendation of the Board of  
15       Estimates, the City Council by ordinance may authorize the transfer of an appropriation  
16       contained in the Ordinance of Estimates from one municipal agency to another municipal  
17       agency.

18       The sum of \$4,564,341, as appropriated to M-R Debt Service (Service 123 - General Debt  
19       Service) in the Fiscal 2024 Ordinance of Estimates, is not needed for the purpose for which it  
20       was appropriated and, therefore, is available for transfer to another agency.

21       On February 5, 2025, the Board of Estimates recommended the transfer authorized by this  
22       Ordinance.

23       **SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE,** That the  
24       sum of \$4,564,341, contained in the Fiscal 2024 Ordinance of Estimates as a General Fund  
25       Operating Appropriation, is transferred from M-R Debt Service (Service 123 - General Debt  
26       Service) to the Office of the Sheriff (Service 882 - Deputy Sheriff Enforcement).




