SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the 16 Department of Public Works shall proceed to condemn and open certain alleys lying within the 17 Washington Hill Chapel Urban Renewal Area Project, bounded by Lombard Street, Broadway, 18 Baltimore Street, and Ann Street, and more particularly described as follows: 19

Beginning for Parcel No. 1 at the point formed by the intersection of the south 20 side of a 15.5-foot alley, laid out in the rear of the properties known as No. 21 1701/1721 E. Baltimore Street, and the east side of a 4-foot alley, laid out in the 22 rear of the properties known as No. 11/23 through No. 31 Yogurt Lane, said point 23 of beginning being distant westerly 54.2 feet, more or less, measured along the 24 south side of said 15.5-foot alley from the west side of Regester Street, 20 feet 25 26 wide, and running thence binding on the east side of said 4-foot alley, Southerly 149.2 feet, more or less, to intersect the north side of a 4-foot alley, laid out in the 27 rear of the properties known as No. 1704 through No. 1706/1712 E. Lombard 28 Street; thence binding on the north side of last said 4-foot alley, Westerly 4.0 feet 29

to intersect the west side of said 4-foot alley, mentioned firstly herein; thence binding on the west side of said 4-foot alley, mentioned firstly herein, Northerly 149.2 feet, more or less, to intersect the south side of said 15.5-foot alley, and thence binding on the south side of said 15.5-foot alley, Easterly 4.0 feet to the place of beginning.

Beginning for Parcel No. 2 at the point formed by the intersection of the south 6 side of a 4-foot alley, laid out in the rear of the property known as No. 1720 E. 7 Lombard Street, and the east side of Regester Street, 20 feet wide, said point of 8 beginning being distant northerly 67.00 feet, measured along the east side of said 9 Regester Street from the north side of Lombard Street, 60 feet wide, and running 10 thence binding on the east side of said Regester Street, Northerly 4.0 feet to 11 intersect the north side of said 4-foot alley; thence binding on the north side of 12 said 4-foot alley, Easterly 67.5 feet, more or less, to the easternmost extremity of 13 said 4-foot alley, there situate; thence binding on the easternmost extremity of 14 said 4-foot alley, Southerly 4.0 feet to intersect the south side of said 4-foot alley, 15 and thence binding on the south side of said 4-foot alley, Westerly 67.5 feet, more 16 17 or less, to the place of beginning.

Beginning for Parcel No. 3 at the point formed by the intersection of the north 18 19 side of a 4-foot alley, laid out in the rear of the property known as No. 1720 E. Lombard Street, and the west side of a 3-foot alley, contiguous to the west outline 20 of the property known as No. 1732/34 E. Lombard Street, there situate, said point 21 of beginning being distant easterly 64.5 feet, more or less, measured along the 2.2 north side of said 4-foot alley from the east side of Regester Street, 20 feet wide, 23 and running thence binding on the west side of said 3-foot alley, Northerly 108.5 24 feet, more or less, to the northernmost extremity of said 3-foot alley, there situate; 25 thence binding on the northernmost extremity of said 3-foot alley, Easterly 3.0 26 feet to intersect the west outline of said 3-foot alley; thence binding on the west 27 outline of said 3-foot alley, Southerly 108.5 feet, more or less, to intersect the 28 29 north side of said 4-foot alley, and thence binding on the north side of said 4-foot alley, Westerly 3.0 feet to the place of beginning. 30

As delineated on Plat 114-A-12, prepared by the Survey Control Section and filed on March 1,
2006, in the Office of the Department of Public Works.

SECTION 2. AND BE IT FURTHER ORDAINED, That the proceedings for the condemnation and opening of certain alleys and the rights of all interested parties shall be regulated by and in accordance with all applicable provisions of state and local law and with all applicable rules and regulations adopted by the Director of Public Works and filed with the Department of Legislative Reference.
