Recitals

The Urban Renewal Plan for Inner Harbor East was originally approved by the Mayor and City Council of Baltimore by Ordinance 71-1188 and last amended by Ordinance 03-614.

An amendment to the Urban Renewal Plan for Inner Harbor East is necessary to revise the specific lot controls applicable to Development Area Q3 and to make minor technical corrections.

Under Article 13, § 2-6 of the Baltimore City Code, no substantial change may be made in
 any approved renewal plan unless the change is approved in the same manner as that required for
 the approval of a renewal plan.

1 2	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE , That the following changes in the Urban Renewal Plan for Inner Harbor East are approved:
3	(1) In the Plan, amend F.2.b.(3) to read as follows:
4	(3) <u>Planned Development</u> : Such other uses as are permitted in certain portions of the
5	Urban Renewal Area that are now or may later be subject to any Planned UNIT
6	Development ("PUD"), created pursuant to [Chapter 12 of Article 30 of the
7	Baltimore City Code] TITLE 9 OF THE ZONING CODE OF BALTIMORE CITY.
8	(2) In the Plan, amend G.14.a.(2) to read as follows:
9	(2) <u>Development Area Q3</u>
10	The specific lot area controls and the specific development program
11	within Development Area $\mathrm{Q3}$ shall be as set forth in any applicable
12	PUD. It is HOWEVER the objective of this Plan that within this Development
13	Area, the following development program shall be outlined:
14	A minimum of [275,000] 800,000 square feet in the aggregate of primary office
15	space, residential UNITS and/or [ground floor] retail[;], provided that a maximum
16	of 250 hotel rooms may be developed AS WELL, so long as such development is
17	completed as part of an overall development plan for this Development Area that
18	ALSO includes the foregoing office, residential, and/or retail space.
19	The size and configuration of the Development Area shall generally be as
20	illustrated on Exhibit B.
21	(3) In the Plan, amend G.14.e. to read as follows:
22	e. <u>Development Area Q3:</u>
23	The maximum permitted building height on Development Area Q3 [is 180.0 feet
24	above grade] SHALL NOT EXCEED THE HEIGHTS SET FORTH IN ANY APPLICABLE
25	PUD.
26	SECTION 2. AND BE IT FURTHER ORDAINED, That the Urban Renewal Plan for Inner Harbor
20	East, as amended by this Ordinance and identified as "Urban Renewal Plan, Inner Harbor East,
28	revised to include Amendment , dated March 26, 2007", is approved. The Department of
29	Planning shall file a copy of the amended Urban Renewal Plan with the Department of
30	Legislative Reference as a permanent public record, available for public inspection and
31	information.
32	SECTION 3. AND BE IT FURTHER ORDAINED, That if the amended Urban Renewal Plan
33	approved by this Ordinance in any way fails to meet the statutory requirements for the content of
34	a renewal plan or for the procedures for the preparation, adoption, and approval of a renewal
35	plan, those requirements are waived and the amended Urban Renewal Plan approved by this
36	Ordinance is exempted from them.

SECTION 4. AND BE IT FURTHER ORDAINED, That if any provision of this Ordinance or the application of this Ordinance to any person or circumstance is held invalid for any reason, the

invalidity does not affect any other provision or any other application of this Ordinance, and for
 this purpose the provisions of this Ordinance are declared severable.

SECTION 5. AND BE IT FURTHER ORDAINED, That if a provision of this Ordinance concerns 3 the same subject as a provision of any zoning, building, electrical, plumbing, health, fire, or 4 5 safety law or regulation, the applicable provisions shall be construed to give effect to each. However, if the provisions are found to be in irreconcilable conflict, the one that establishes the 6 higher standard for the protection of the public health and safety prevails. If a provision of this 7 Ordinance is found to be in conflict with an existing provision of any other law or regulation that 8 establishes a lower standard for the protection of the public health and safety, the provision of 9 this Ordinance prevails and the other conflicting provision is repealed to the extent of the 10 conflict. 11

12 SECTION 6. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it 13 is enacted.
