BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That 24 \$200,000 shall be made available to the MR-Miscellaneous General Expenses – Program 122 25 (Miscellaneous General Expenses) as a Supplementary General Fund Operating Appropriation 26 for Fiscal Year 2008, to provide funding for the Pediatric Hospice Program. The source of 27 revenue for this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the 28
