13	The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund
14	Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy
15	required to balance the budget for Fiscal Year 2008.
16	This additional revenue could not have been reasonably anticipated when the Ordinance of
17	Estimates for Fiscal Year 2008 was formulated.
18	This appropriation is made necessary by a material change in circumstances since the
19	Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could
20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
21	On June 27, 2007, the Board of Estimates recommended this appropriation to the City
22	Council.
23	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
24	\$500,000 shall be made available to the MR-Miscellaneous General Expenses – Program 122
25	(Miscellaneous General Expenses) as a Supplementary General Fund Operating Appropriation
