14	The revenue appropriated by this Ordinance represents funds from the Fiscal 2007 Fund
15	Balance in excess of the revenue relied on by the Board of Estimates in determining the tax levy

17	This additional revenue could not have been reasonably anticipated when the Ordinance of
18	Estimates for Fiscal Year 2008 was formulated.
19	This appropriation is made necessary by a material change in circumstances since the
20	Ordinance of Estimates for Fiscal Year 2008 was formulated or is for a new program that could
21	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
22	On July 11, 2007, the Board of Estimates recommended this appropriation to the City
23	Council.

The source of revenue for this appropriation is funds from the Fiscal 2007 Fund Balance in excess of the amount from this source that was relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2008.
