16 SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That the 17 Department of Public Works shall proceed to condemn and open certain streets and alleys lying 18 within the area bounded by 24th Street, Howard Street, 25th Street, and Maryland Avenue, and

19 more particularly described as follows:

Beginning for Parcel No. 1 at the point formed by the intersection of the north 20 side of 24th Street, 66 feet wide, and the west side of Mace Street, 20 feet wide, 21 and running thence binding on the west side of said Mace Street, Northerly 465.0 22 feet, more or less, to intersect the south side of 25th Street, 100 feet wide; thence 23 binding on the south side of said 25th Street, Easterly 20.0 feet to intersect the 24 east side of said Mace Street; thence binding on the east side of said Mace Street, 25 Southerly 465.0 feet, more or less, to intersect the north side of said 24th Street, 26 27 and thence binding on the north side of said 24th Street, Westerly 20.0 feet to the place of beginning. 28

1 Beginning for Parcel No. 2 at the point formed by the intersection of the north 2 side of 24th Street, 66 feet wide, and the east side of a 10 foot alley laid out in the rear of the properties formerly known as Nos. 2400 through 2424 Maryland 3 Avenue, said point of beginning being distant westerly 84.0 feet, more or less, 4 5 measured along the north side of said 24th Street from the west side of Maryland Avenue, 66 feet wide, and running thence binding on the north side of said 24th 6 Street, Westerly 10.0 feet to intersect the west side of said 10 foot alley; thence 7 binding on the west side of said 10 foot alley, Northerly 184.0 feet, more or less, 8 to the northernmost extremity of said 10 foot alley; thence binding on the 9 northernmost extremity of said 10 foot alley, Easterly 10.0 feet to intersect the 10 east side of said 10 foot alley, and thence binding of the east side of said 10 foot 11 alley, Southerly 184.0 feet, more or less, to the place of beginning. 12

- Beginning for Parcel No. 3 at the point formed by the intersection of the south 13 side of a 12 foot to varying in width alley laid out along the northern outline of 14 the property known as No. 2403/17 Mace Street, and the east side of Mace Street, 15 16 20 feet wide, said point of beginning being northerly 172.0 feet, more or less, measured along the east side of said Mace Street from the north side of 24th 17 Street, 66 feet wide, and running thence binding on the east side of said Mace 18 19 Street, Northerly 12.0 feet to intersect the north side of said 12 foot to varying in width alley; thence binding on the north side of said 12 foot to varying in width 20 alley, Easterly 56.0 feet, more or less, to intersect the west side of a 10 foot alley 21 laid out in the rear of the properties formerly known as Nos. 2400 through 2424 22 Maryland Avenue; thence binding on the west side of said 10 foot alley, 23 Southerly 22.0 feet, more or less, to intersect the southeast side of said 12 foot to 24 varying in width alley; thence binding on the southeast side of said 12 foot to 25 varying in width alley, Northwesterly 14.1 feet, more or less, to the south side of 26 said 12 foot to varying in width alley, and thence binding on the south side of said 27 12 foot to varying in width alley, Westerly 46.0 feet, more or less, to the place of 28 29 beginning.
- Beginning for Parcel No. 4 at the point formed by the intersection of the south 30 side of a 10 foot alley laid out in the rear of the property known as No. 102 W. 31 24th Street, and the east side of Mace Street, 20 feet wide, said point of beginning 32 33 being distant northerly 65.0 feet, more or less, measured along the east side of said Mace Street from the north side of 24th Street, 66 feet wide, and running 34 thence binding on the east side of said Mace Street, Northerly 10.0 feet to 35 intersect the north side of said 10 foot alley; thence binding on the north side of 36 said 10 foot alley, Easterly 56.0 feet, more or less, to intersect the west side of a 37 10 foot alley laid out in the rear of the properties formerly known as Nos. 2400 38 through 2424 Maryland Avenue: thence binding on the west side of said 10 foot 39 alley, mentioned secondly herein, Southerly 10.0 feet to intersect the south side of 40 41 said 10 foot alley, mentioned firstly herein, and thence binding on the south side of said 10 foot alley, mentioned firstly herein, Westerly 56.0 feet, more or less, to 42 43 the place of beginning.

SECTION 2. AND BE IT FURTHER ORDAINED, That the proceedings for the condemnation and opening of the streets and alleys and the rights of all interested parties shall be regulated by and in accordance with all applicable provisions of state and local law and with all applicable rules and regulations adopted by the Director of Public Works and filed with the Department of Legislative Reference.

6 SECTION 3. AND BE IT FURTHER ORDAINED, That this Ordinance takes effect on the date it 7 is enacted.
