AN ORDINANCE CONCERNING

Fire and Police Employees' Retirement System – Benefits

For the purpose of modifying certain Fire and Police Employees' Retirement System interest rate assumptions; changing the definition of "average final compensation" for all System members who do not meet certain conditions; clarifying the definition of "earnable compensation;" making the Director of Finance an ex-officio member of the Board of Trustees of the System; allowing the Director of Finance to authorize a designated representative to act in his or her stead at board meetings; adding 1 additional Board of Trustees appointee, appointed from a list of recommended candidates submitted by the President of the City Council, to the existing 2 City resident mayoral appointees; establishing new qualifications for the mayoral appointees; exempting the Board of Trustees from the City Charter provision requiring minority party representation on City boards; changing the age and service requirements for the normal service retirement benefit for all System members who do not meet certain conditions; establishing a new early service retirement benefit for System members who do not qualify for normal service retirement; increasing the percentage of compensation contributable by System members; amending provisions of the System law pertaining to post-retirement increases by discontinuing the variable benefit increase and substituting a fixed percentage increase; discontinuing the utilization of certain existing System accounting reserves; clarifying the existing DROP 2 eligibility provisions and establishing new DROP 2 eligibility provisions for System members who do not meet certain conditions; establishing a minimum benefit for certain retirees and beneficiaries; providing for a special effective date dates; and generally relating to the Fire and Police Employees' Retirement System of the City of Baltimore.

12	WHEREAS, it is estimated that the City's required annual contribution to the Fire and Police
13	Employees' Retirement System ("F&P") for FY2011, before accounting for the cost of F&P's
14	variable post-retirement benefit increases, will be \$101 million.
15	WHEREAS, the City's required annual contribution to F&P has risen approximately 270%
16	from \$27.3 million in FY2001 to a budgeted \$101 million in FY2011. Expressed as a percentage
17	of the City's general fund operating budget, this equals an increase from 1.3% of budget in
18	FY2001 to 4.6% of budget in FY2011.
19	WHEREAS, while the City's covered fire and police payroll used for calculating the City's
20	annual F&P contribution during the 10-year period starting with FY2001 and ending with
21	FY2011 increased from approximately \$181.4 million to \$280.2 million, or 54%, the City's
22	required annual contribution to F&P during the same period rose from approximately \$27.3
23	million to a budgeted \$101 million, or 270%.
24	WHEREAS, Article 22 of the City Code currently includes a variable post-retirement benefit
25	formula that provides increases to F&P retirees and beneficiaries in years in which the system
26	achieves positive investment performance, but makes no provision for negative investment
27	performance years.
28	WHEREAS, the current formula results in a diminished asset base under which the F&P
29	cannot fully benefit from good investment performance since it must share a portion of investment
30	earnings with retirees in good years but must bear the total impact of investment losses in bad
31	years.
32	WHEREAS, it is now estimated that the annual F&P contribution needed to maintain the
33	current variable post-retirement benefit increase structure is an additional \$64 million on top of
34	the budgeted \$101 million required annual contribution, which would bring to \$165 million the
35	total annual contribution to F&P by the City for FY2011.
26	WHEREAS, in its FY2011 budget the City projects a \$121 million budget gap which is
36 37	presently projected to be closed only after reducing basic services, closing facilities, and
38	furloughing and laying off employees or by raising City taxes.

39 40	WHEREAS, the City's Fiscal 2011 Preliminary Budget Plan reports that "The major driver of cost growth is the City's pension contributions. Because of poor investment performance in

1 2 3	Fiscal 2009, the pension funds need an additional \$28 million from the General and Motor Vehicle funds to remain financially sound. Without legislation to reform the variable benefit provision of the Fire and Police Retirement System, this cost grows by another \$64 million".
4 5 6 7 8 9 10	WHEREAS, a task force of the Greater Baltimore Committee recently issued its summary report on the sustainability of F&P and found that current contributions to fund the F&P are inadequate to fully cover its existing and anticipated liabilities, that the funded ratio of the F&P based on a June 30, 2009 market value is only 58.2%, and that the F&P underfunding problem "threatens the City's fiscal stability and could result in a reduction in City services, increased taxes, and a decline of the City's bond rating – a combination of adverse circumstances that would result in immediate and long term financial burdens on the City and its citizens".
11 12 13 14 15	WHEREAS, an independent actuary and an independent financial consultant have confirmed that the F&P, as presently constituted, is unsustainable given the City's structural budgetary deficit constraints and have recommended changing F&P's benefit structure in order to reduce the F&P's present and future actuarial liability and the City's concomitant annual contribution to the F&P.
16 17 18	WHEREAS, the City Council has given careful consideration to recommendations put forward by the union representatives of F&P members regarding the sustainability of F&P and the contractual rights of its members.
19 20 21 22	WHEREAS, the City Council has concluded that it is necessary and reasonable to implement the recommendations of the independent actuary and financial consultant by modifying the current F&P benefit structure in order to restore the actuarial soundness of F&P in a manner that minimizes diminution of benefits to F&P members.
