3	FOR the purpose of providing a Supplementary Federal Appropriation in the amount of \$750,000			
4	to the Department of General Services (Program #9916), to provide funding for the "Project			
5	Sunburst" Grant; and providing for a special effective date.

11	Recitals			
12	The revenue appropriated by this Ordinance represents a grant from Federal Revenue			
13	administered through the Maryland Energy Administration in excess of the revenue relied on by			
14	the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year			
15	2011.			
16	That grant could not have been expected with reasonable certainty when the Ordinance of			
17	Estimates for Fiscal Year 2011 was formulated.			
18	On October 13, 2010, the Board of Estimates recommended this appropriation to the City			
19	Council.			
20	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That			
21	\$750,000 shall be made available to the Department of General Services (Program #9916) as a			
22	Supplementary Federal Appropriation for Fiscal Year 2011, to provide funding for the "Project			
23	Sunburst" Grant. The source of revenue for this appropriation is the grant from Federal Revenue			
24	administered through the Maryland Energy Administration in excess of the amount from this			
25	source that was relied on by the Board of Estimates in determining the tax levy required to			
26	balance the budget for Fiscal Year 2011.
