13	The revenue appropriated by this Ordinance represents funds from the Fiscal 2012 Fund
14 15	Balance, from Highway User Revenue, in excess of the revenue relied on by the Board of Estimates in determining the tax levy required to balance the budget for Fiscal Year 2013.
16	This additional revenue could not have been reasonably anticipated when the Ordinance of
17	Estimates for Fiscal Year 2013 was formulated.
18	This appropriation is made necessary by a material change in circumstances since the
19	Ordinance of Estimates for Fiscal Year 2013 was formulated or is for a new program that could
20	not have been reasonably anticipated when that Ordinance of Estimates was formulated.
21	On September 12, 2012, the Board of Estimates recommended this appropriation to the City

23	SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That
20	\$7 200,000 shall be made available to the Department of Transportation (A acount #0050
