REQUEST: City Council Bill #12-0123/ Building, Fire, and Related Codes – 2012 Edition For the purpose of adopting a revised Building, Fire, and Related Codes Article, comprising the Maryland Building Performance Standards (effective January 1, 2012), the International Building Code (2012 Edition), the International Electrical Code (2011 Edition), the International Fuel Gas Code (2012 Edition), the International Mechanical Code (2012 Edition), the International Property Maintenance Code (2012 Edition), the International Fire Code (2012 Edition), the International Energy Conservation Code (2012 Edition), and the International Residential Code for One- and Two-Family Dwellings (2012 Edition), all as supplemented, amended, or otherwise modified by this Ordinance; providing for the effect, construction, and effective date of these new standards and codes; conforming, correcting, and clarifying certain language; and generally relating to the adoption of new building, fire, property maintenance, electrical, plumbing, mechanical, and related codes for Baltimore City.

HISTORY

- Ordinance #07-552, dated November 26, 2007, revised the Baltimore City Building, Fire, and Related Codes, incorporating the 2006 series of related International Building Codes and related documents.
- Ordinance #11-419, dated March 7, 2011, was the latest revision to the Baltimore City Building, Fire, and Related Codes, incorporating the 2009 series of related International Building Codes and related documents.

CONFORMITY TO PLANS

This bill is compatible with the Comprehensive Master Plan's LIVE section, Goal Two: Elevate the Design and Quality of the City's Built Environment.

ANALYSIS

<u>Periodic Update</u>: A new version of the International Building Code (IBC) is written and released every three years. The update is then adopted into State law under the Maryland Building Performance Standards (MBPS). As most recently made effective, dated January 1, 2012, these Standards consist of three parts: the 2012 IBC, the 2012 International Residential Code for One-and Two-Family Dwellings, and the 2012 International Energy Conservation Code. After adoption at the State level with their modifications, local jurisdictions may then adopt the same Standards – either in whole or in parts, and with local modifications.

In order to adopt a new building code, Baltimore City must review and amend our code by adopting the IBC code series, including State modifications, and adopt changes that reflect conditions or needs that are unique to the City. Those amendments are then adopted as the latest version of the Baltimore City Building, Fire, and Related Codes.

The purpose of the bill is to adopt a new Building, Fire, and Related Codes Article comprised of the latest Maryland Building Performance Standards and latest IBC series of codes (2012 edition), with the following highlights:

- The National Fuel Gas Code and the National Standard Plumbing Code are removed and replaced with the new International Fuel Gas Code and the International Plumbing Code.
- Amendments are made to the Building, Fire, and Related Codes in Parts I to III and VII to X to conform language.
- Amendments are made to the Health Article to conform language.
- Amendments are made to the Zoning Article to conform language.
- Amendments are made to Article 1 Mayor, City Council, and Municipal Agencies to correct references.
- Amendments are made to Article 7 Natural Resources to conform language.
- Amendments are made to the Article 13 Housing and Urban Renewal to conform language.
- Amendments are made to the Article 15 Licensing and Regulation to conform language.
- Amendments are made to the Article 19 Police Ordinances to correct references.
- Amendments are made to the Article 24 Water to conform language.

Recommendation: Staff recommends approval of this update.
