27	(ii) sold, offered, or conducted on the premises only incidentally if at all.					
28	(2) "General advertising sign" does not include a sign that:					
29 30	(i) is attached to a bus passenger shelter[;] and [(ii)] complies fully with all requirements of § 11-424 of this title; OR					
31 32	(ii) IS ATTACHED TO A BIKE-SHARING STATION AND COMPLIES FULLY WITH ALL REQUIREMENTS OF § 11-425 OF THIS TITLE.

1	§ 11-425. ADVERTISING SIGNS ON BIKE-SHARING STATIONS.
2	(A) IN GENERAL.
3 4	ADVERTISING SIGNS ON BIKE-SHARING STATIONS ARE ALLOWED AS PROVIDED IN THIS SECTION.
5	(B) LIMITATIONS.
6 7	(1) IN ALL DISTRICTS, THESE SIGNS ARE SUBJECT TO THE FOLLOWING REQUIREMENTS.
8 9	(2) THE SIGN DISPLAY AREA MUST BE INTEGRAL TO THE DESIGN OF THE BIKE-SHARING STATION.
10	(3) NO SIGN MAY EXTEND FROM THE FACE OF THE BIKE-SHARING STATION.
11	(4) NO SIGN MAY EXTEND ABOVE THE TOP OF THE BIKE-SHARING STATION.
12 13 14 15 16	(5) THE ADVERTISING SIGN AREA MAY NOT EXCEED 25 16 SQUARE FEET ON ONE EACH SIDE. THE SIGN MAY BE DOUBLE-SIDED. INFORMATIONAL SIGNS, BIKE PATH INFORMATION, AND MAPS PROVIDED BY THE DEPARTMENT OF TRANSPORTATION ARE NOT INCLUDED WITHIN THIS SIZE LIMIT. A COMMUNITY INFORMATION PANEL IS ALLOWED AND IS NOT INCLUDED WITHIN THIS SIZE LIMIT AS LONG AS IT DOES NOT EXCEED 11" X 17" AND IS PLACED ON THE INSIDE OF THE STATION.
18	(6) NO SIGN MAY ADVERTISE ALCOHOLIC BEVERAGES OR TOBACCO PRODUCTS.
19 20 21	(7) PARTIES ARE ELIGIBLE TO PLACE ADVERTISING ON BIKE-SHARING STATIONS ONLY IF THEY HAVE OBTAINED THE REQUIRED MINOR PRIVILEGE PERMITS FOR EACH STATION THAT IS IN A PUBLIC RIGHT-OF-WAY.
22 23	(8) THE BIKE-SHARING STATION MUST RECEIVE DESIGN APPROVAL FROM THE PLANNING COMMISSION.
24 25	(9) IF LOCATED WITHIN A PUBLIC PARK, THE BIKE-SHARING STATION AND SITE MUST BE APPROVED BY THE DIRECTOR OF RECREATION AND PARKS.
26 27	(10) THE SIGN MUST OTHERWISE COMPLY WITH ALL APPLICABLE REQUIREMENTS OF THIS TITLE.
28 29 30	SECTION 2. AND BE IT FURTHER ORDAINED , That the catchlines contained in this Ordinance are not law and may not be considered to have been enacted as a part of this or any prior Ordinance.
31 32	SECTION 3. AND BE IT FURTHER ORDAINED , That this Ordinance takes effect on the 30 th da after the date it is enacted.
